High-income neighbourhoods offer a wider choice of private or state-subsidised (concertado) schools – institutions with particular qualities that set them apart.


- These schools tend to be among the highest ranked for educational innovation.

In fact, the location of their preferred school is such a crucial factor when buying a new home that it can swing the balance from one area to another.

Spain's selection of private and state-subsidised schools continues to grow, attracting families from across the country and all over the world.

In Forbes' 2021 ranking of the 50 best schools in Spain, Madrid stands head and shoulders above other cities with 18 of the most admired institutions.

s well as the greatest concentration of elite institutions, Madrid now has more schools per capita than many other cities. As of the 2019-2020 academic year, the Madrid region was home to almost 3,400 non-specialist schools (i.e., excluding those with a particular focus on art, languages or


sport). A little over half of these were state schools, more and more of which now offer teaching in two or more languages. Private schools represented just over 30%, with the remainder being state subsidised. However, looking exclusively at the mu-


Madrid boasts an extensive choice of schools, although some are in such high demand that securing a place can be tricky, and entrance requirements can be strict.



drid has seen an upturn in the number of primary, compulsory secondary and bachillerato pupils over the last ten years, depending on the various options. Historically, primary

enrolments have always been higher than the rest.

Examining enrolments in the Madrid region by level of compulsory education excluding the first preschool cycle, where private and state school pupils are more or less equally balanced - we find that private schools admit approximately 10% of pupils at all stages, whereas the intake of state-subsidised schools makes up around 35%. About 50% of all enrolments are in the state sector.

International pupils are most frequently admitted at primary level or in the second cycle of preschool education, representing some 15% of all pupils. State schools attract the greatest number of international pupils at all stages studied.

Nonetheless, according to the most recent available data (2019-2020 academic year) there has been a substantial rise in the number of international pupils attending private schools compared to the previous year: over 17% in primary and the second preschool cycle and over 22% in secondary (pre-16).



TOP SCHOOLS AND THEIR AVERAGE MONTHLY FEES*:

Although many of the best-known institutions can be found to the north and west of the region, where there is more space to grow their facilities, some of the schools with the most glowing reputations are in prime central city locations.

The map on the right indicates the estimated monthly fees (basic package – excluding extras like food and transport) of the top schools in each prime residential area, while the chart below gives an idea of property prices.

TRENDS IN EDUCATION TECHNOLOGY

igitalisation has created new opportunities in every sector, leading to widespread adoption and change. The education sector has lagged slightly behind when it comes to embracing these new tools – even though one of the school system's main aims is to prepare young people to take on the challenges of the future, equipping them with the necessary skills and knowledge to succeed in a changing world.

That said, in light of the pandemic experience we have witnessed a huge leap in the use of Information and Communications Technology (ICT) in schools, with particular progress in the following areas:



Artificial intelligence (AI)

AI is a field of technology that aims to create computer programs capable of rapid learning or logical reasoning in ways that equal or even exceed the human brain.

It has taken on a vital importance in recent years. Algorithms used to detect patterns and trends offer schools a way to pick up on problems at an early stage, for example by highlighting underperforming pupils or those at risk of dropping out.



Cybersecurity and netiquette

The sudden surge in home schooling has brought cybersecurity and netiquette (the rules of courteous online behaviour) to the fore. These two interrelated topics have been core learning priorities for 2021 – another way for schools to give pupils the crucial skills they need to protect their personal data.



Automation

At present, automation in the education sector is something of a minefield, although tools are already available that can streamline certain administrative processes, like managing exams, grades, activities and virtual classrooms. The ultimate goal is to create a virtual learning environment that retains all the fundamental features of a real classroom experience, so that pupils can keep progressing without disruption.



5G Connection

Growing use of ICT in schools has led to an escalation in internet traffic, prompting the need for faster connections. As a result, demand for 5G has grown as schools adapt to a new blended format with more emphasis on remote learning.



Collaborative and digital learning

COVID-19 forced the sector to adapt traditional classroom collaboration techniques to remote teaching, amid pressing calls for more suitable digital platforms. ICT has supported this process, with teachers tapping into the potential of social media, virtual blackboards, online group work using collaborative applications and websites that several pupils can work on simultaneously, thanks to easy-to-use tools.



Mixed reality

This term covers all aspects of virtual reality, augmented reality and immersive reality (devices that create a simulation of the real world), as adapted for educational purposes. The idea is to develop a more virtual teaching environment that holds pupils' attention much more effectively. This trend is beginning to crop up not only in schools but also in universities and professional training.



Gamification is an approach that embraces the logic of games to help pupils learn more effectively and achieve better outcomes. Most pupils are able to absorb information more easily when these techniques are used. Over the last year or so, the amount of educational content converted to digital format has vastly increased the potential for gamification in the classroom – whether real or virtual.
