The landscaped gardens are a particular feature of the property and are well screened on all sides by a stunning array of mature trees, hedges and shrubs.









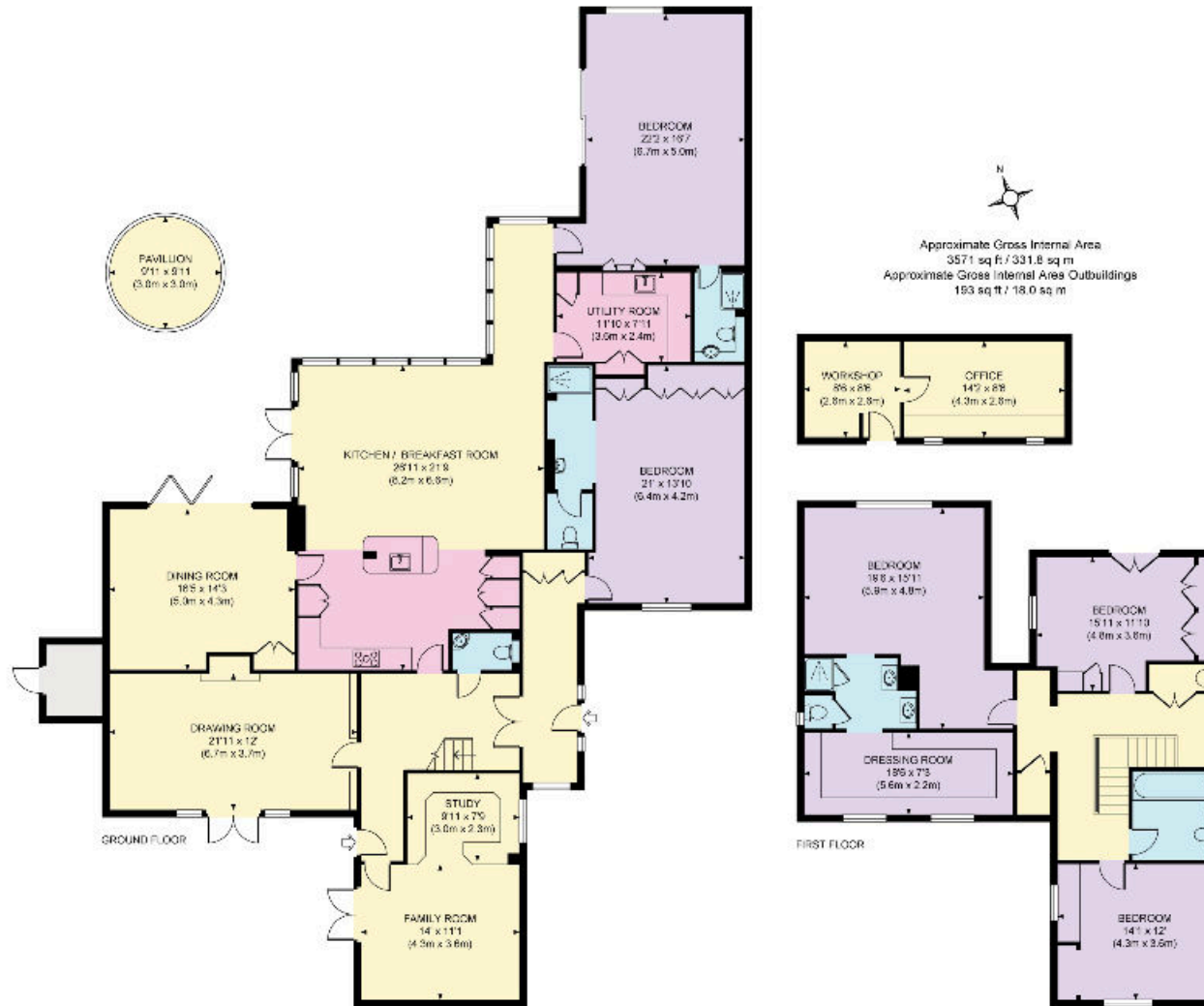
