Bean Oak barn is approached over a graveled driveway offering ample parking to the front of the property. The bright and welcoming entrance hall benefits from a fullheight window to the first floor. It gives access to all of the principal reception rooms, including a family room with fireplace, living room, and study, which lead on to the gardens to the rear.

The beautiful kitchen/breakfast room has a central island with a wide range of wall and base mounted units, and many integrated appliances also lead on to the pretty gardens to the rear.

Additional ground floor accommodation includes a dining room, utility room and separate cloakroom.



























To the first floor, the principle bedroom suite enjoys a dressing room, bathroom with bathtub and walk-in shower. There is a guest bedroom suite and three further bedrooms served by a family bathroom.

To the rear, the private gardens are mainly laid to lawn and feature mature trees and shrubs bordering the fencing. To the front the property benefits from ample parking and there is also a separate double garage along with another smaller barn with vaulted ceiling perfect for storage or entertaining. There is also a summerhouse and a split level patio area for al-fresco dining.
















