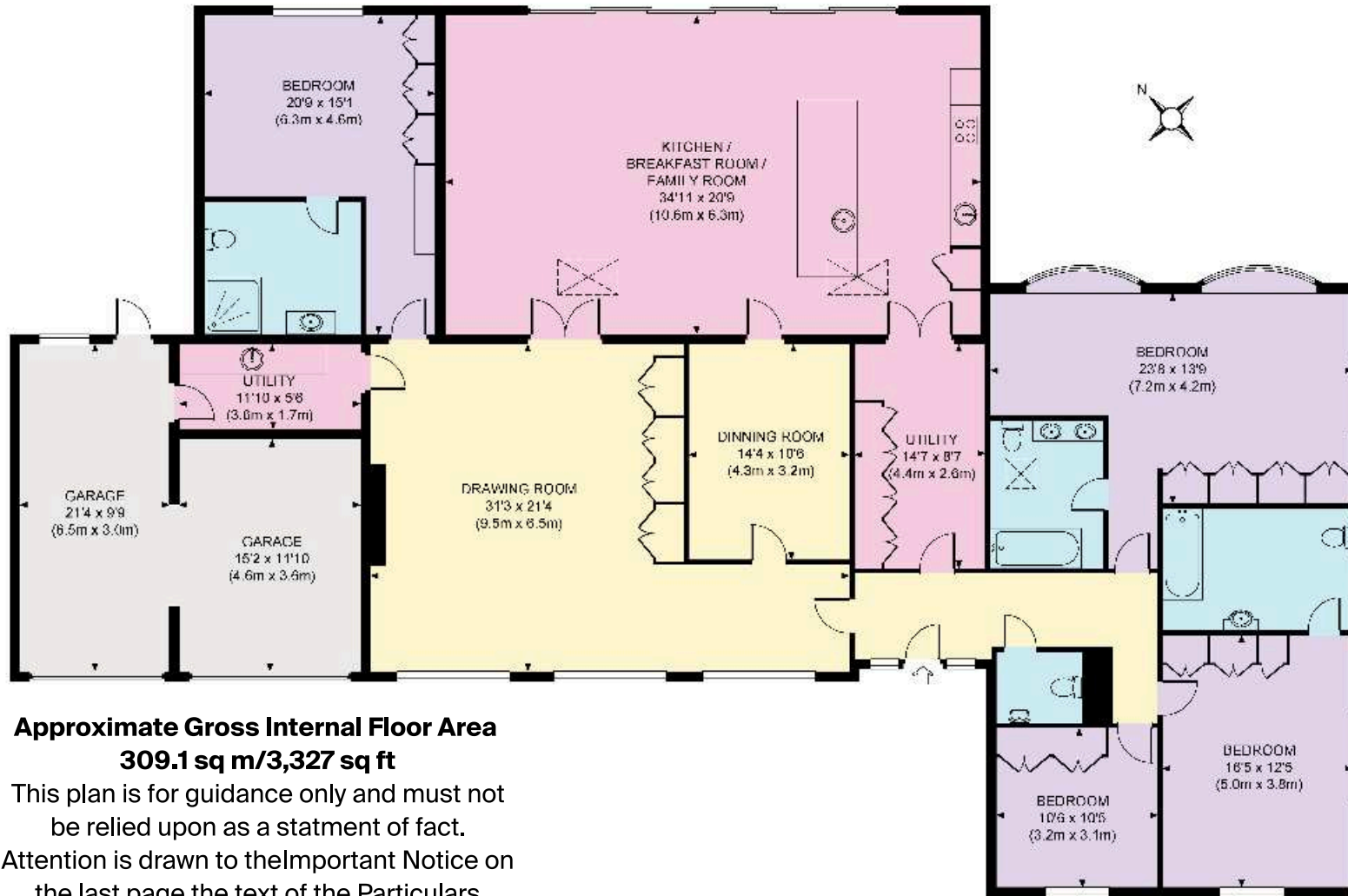


Rondane is a detached bungalow that has been recently updated situated on a mature one-acre plot accessed from Shepley Drive on the world-renowned Wentworth Estate.
