

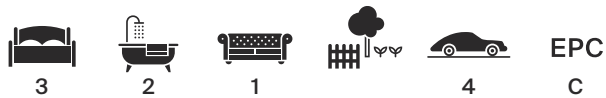


New Lodge Estate, Winkfield, Berkshire SL4

This renovated lodge is located on the edge of a historic private country estate. The property benefits from three double bedrooms, one with an en suite and two sharing the family bathroom. 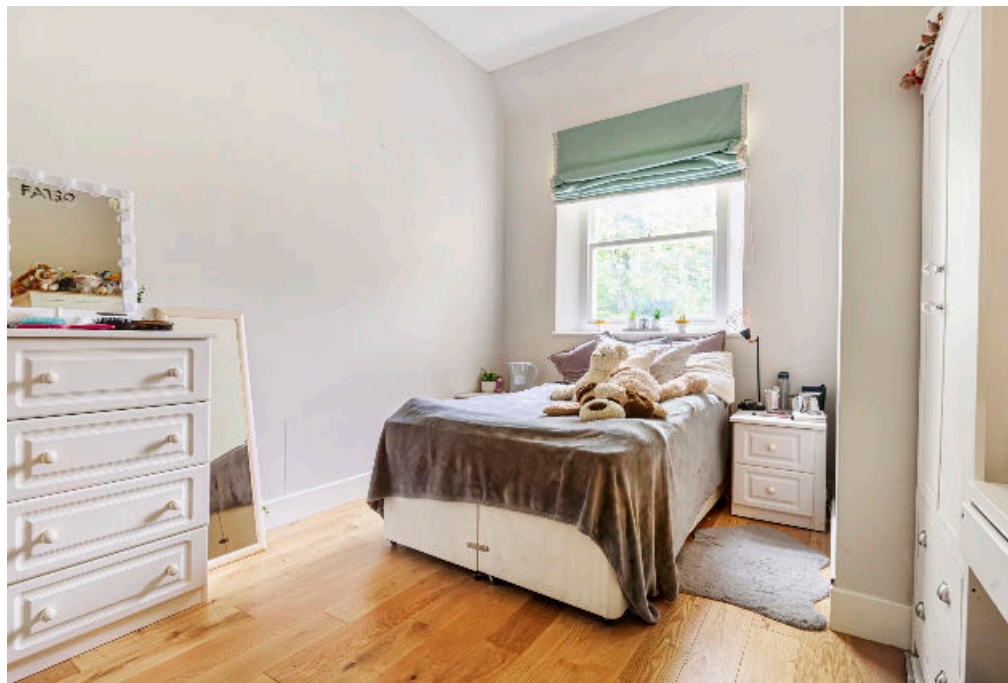

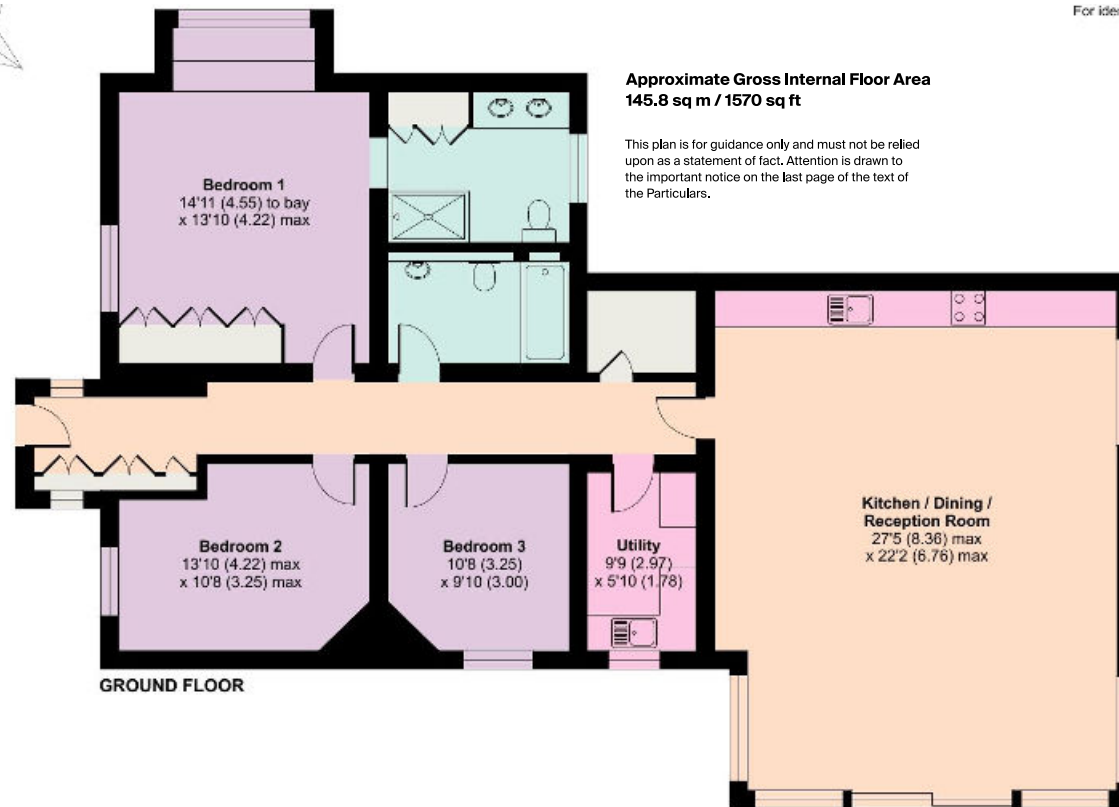
Location

Winkfield has a great transport network, with close proximity to the M25, M4 and M40 motorways and with Heathrow airport (14.3 mi) and Gatwick (45.6 mi) (miles approximated). Education facilities in the area are exceptional and include Lambrook, Heathfield, Eton College, Papplewick, Charters, LVS, Hall Grove, The Marist, St George's Ascot, Wellington, St Mary's and Sunningdale School. There are also two highly regarded international schools, ACS and TASIS. Sporting facilities in the area include golf at Sunningdale, Berkshire and Wentworth, polo at Smith's Lawn, The Royal County of Berkshire Polo Club, and horseracing at Ascot and Windsor. Other attractions in the area include Virginia Water Lake, Savill Gardens, Windsor Great Park, Windsor Castle and Legoland.
