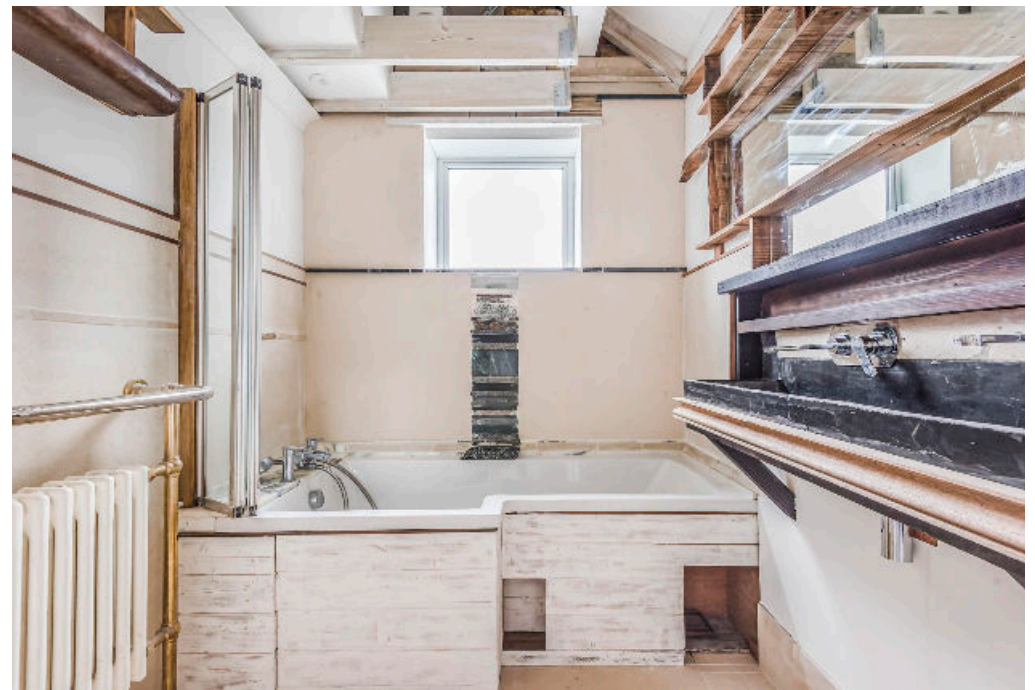
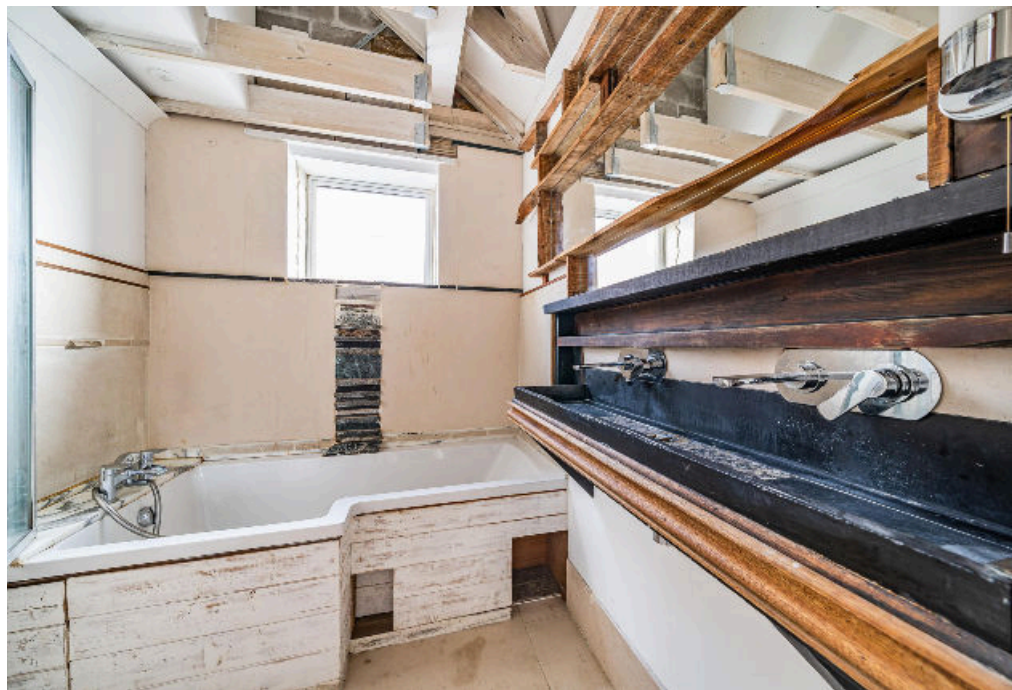

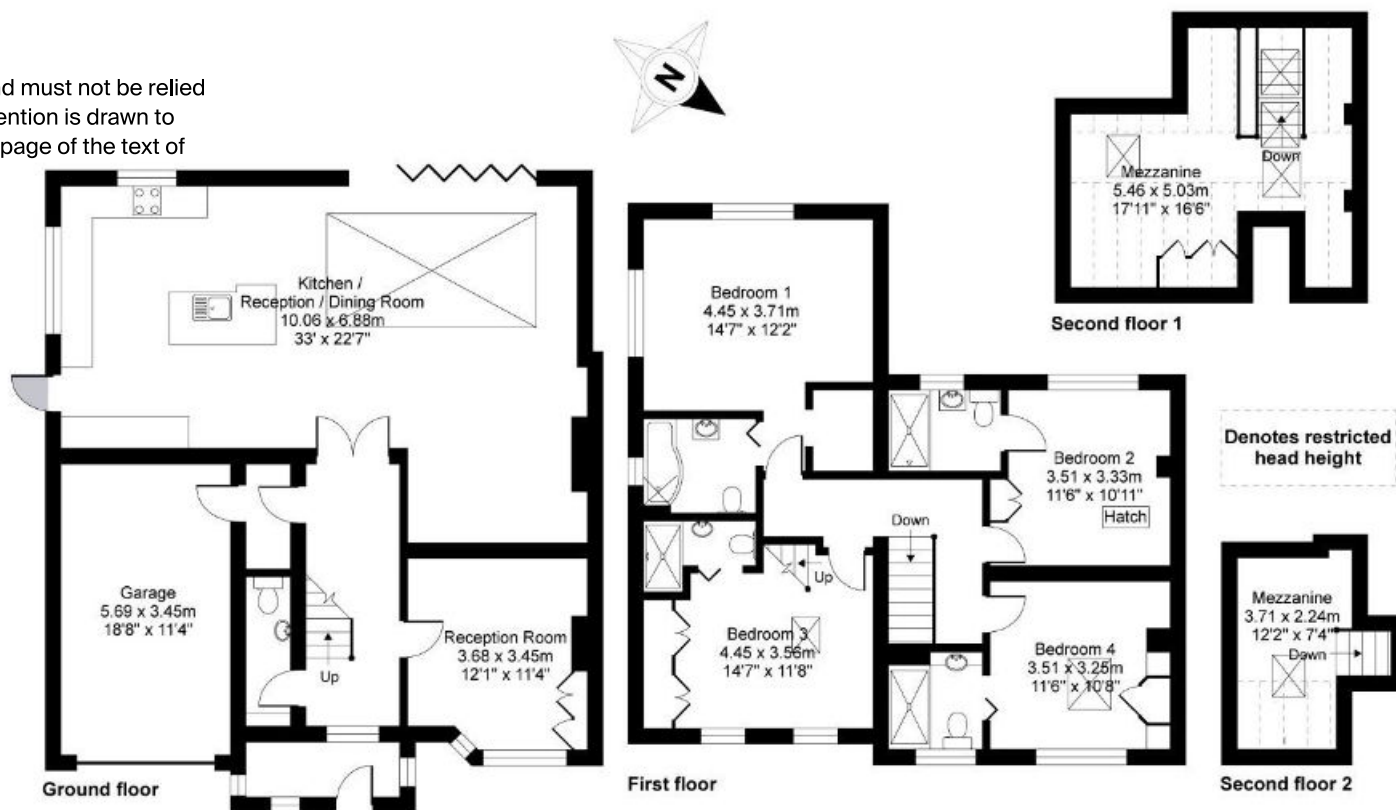


Location
