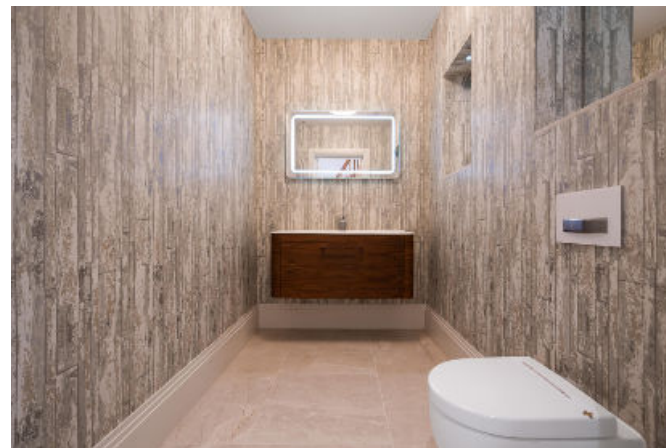

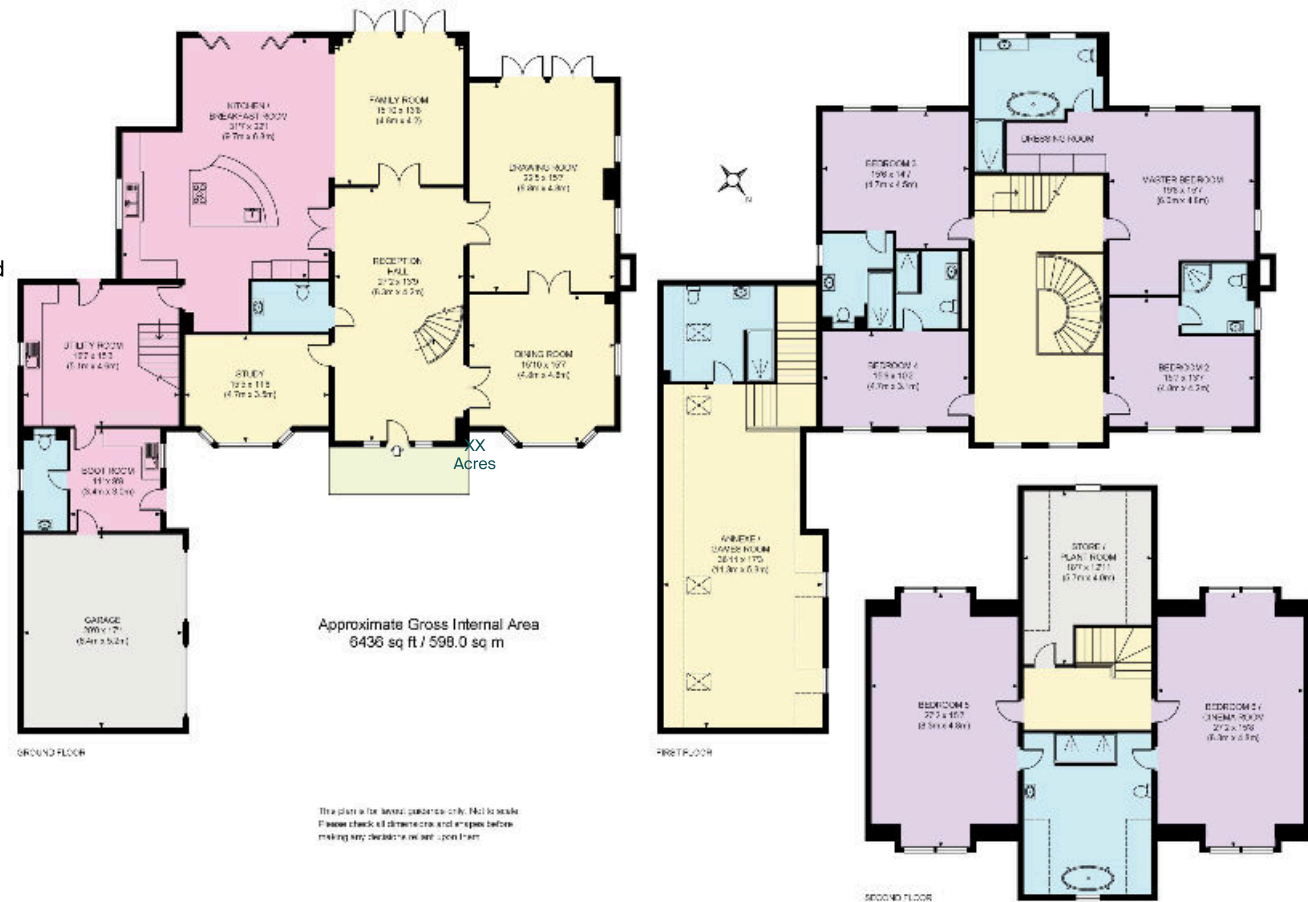
Location
