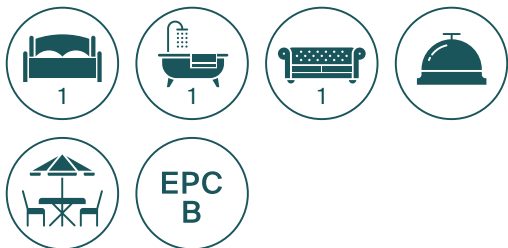


Warwick Building, Battersea SW11

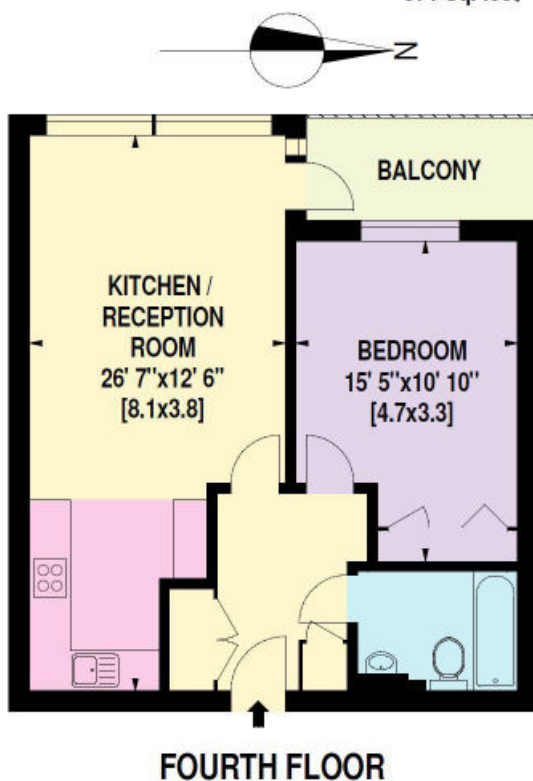
