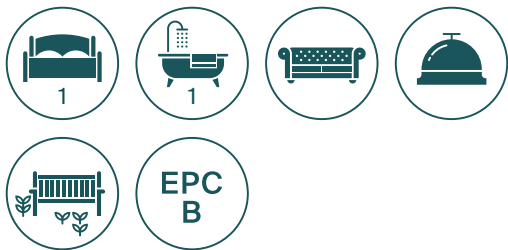


Lighterman Towers, Chelsea SW10

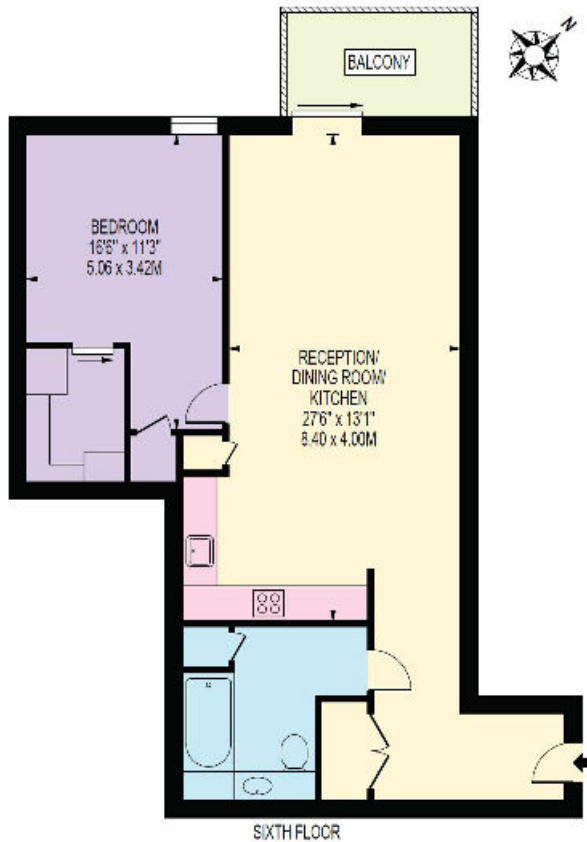
