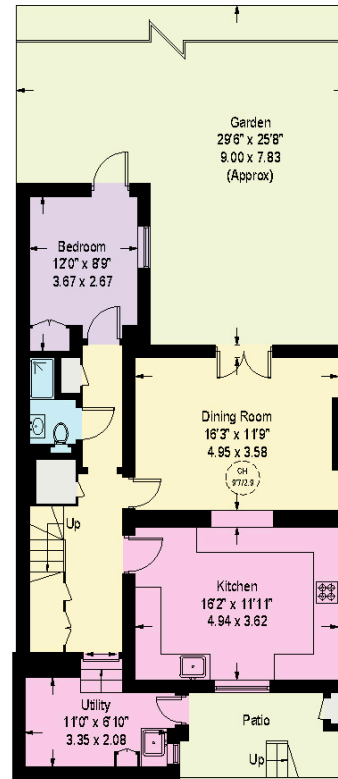

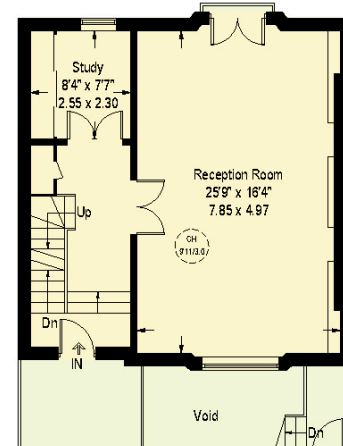

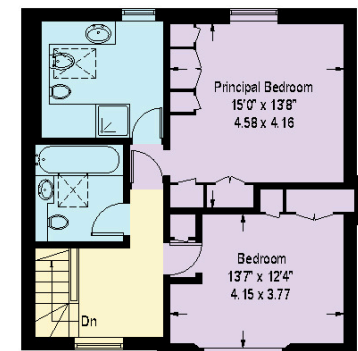




Lower Ground Floor
