The house is built to a high standard with Schuco aluminium windows and doors throughout, under floor heating, a Lutron lighting system, a multi zoned audio and TV surround sound system throughout and Cat 5 cabling for rapid data transfer. Beautiful polished limestone flooring is laid throughout the house and compliments the ash skirting boards and doors. Heat recovery/ ventilation and central vacuum are provided to all floors.

Novus is approached through a driveway where there is space for three cars with a locked bike store and secure side access to the garden. The garden has a large terrace of hammered limestone, perfect for entertaining, overlooking a garden laid to a raised lawn and well stocked flower beds. The lawn leads to a decked area with a garden room supplied with hot water and electricity, TV, audio and data points. A further area of paved garden lies to the side of the garden room. All outside areas have external ground and wall lighting to continue enjoyment into the evening.
