The flat is entered on the first floor, and accommodation begins on the second floor, which comprises the reception room with a light and bright feeling due to its over 3-meter ceiling heights, adjoining kitchen, access to a flat roof and W/ C. The private roof terrace faces west/southwest and benefits from the afternoon sun. On the half-landing, there is the utility room. The third floor comprises the principal bedroom suite overlooking the garden square, a second bedroom with a bathroom suite, and a study, which could be used as a fifth bedroom.
