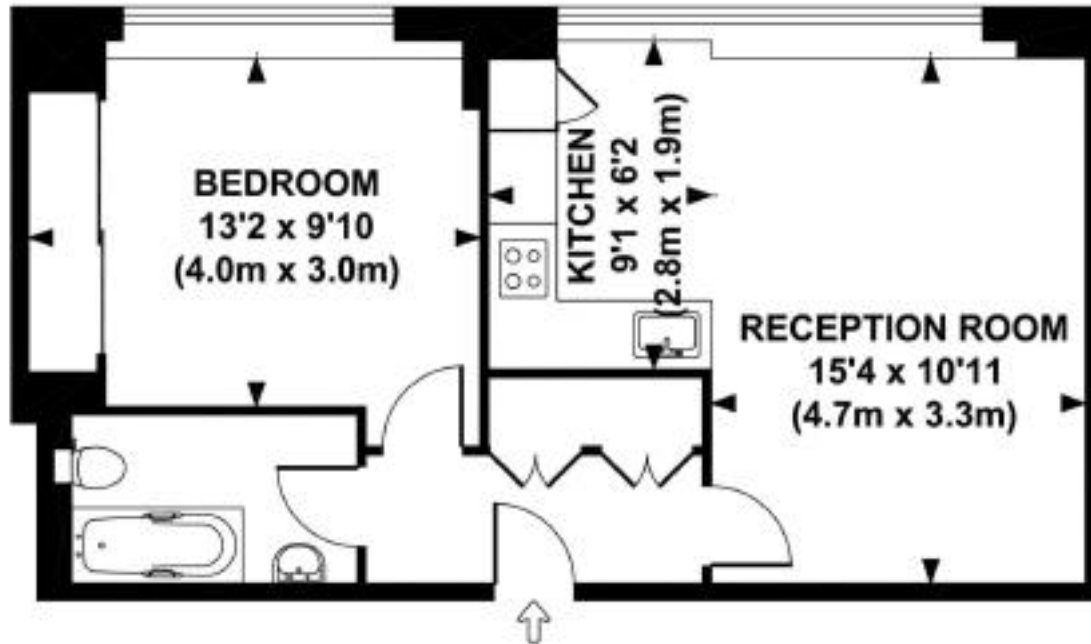
The stylish accommodation features beautiful light wood floors to the reception room, neutral decor and high quality fixtures and furnishings.
