This is a beautifully presented flat situated on the raised ground floor of a pretty Victorian conversion in Westgate Terrace, a quiet residential street in Chelsea.

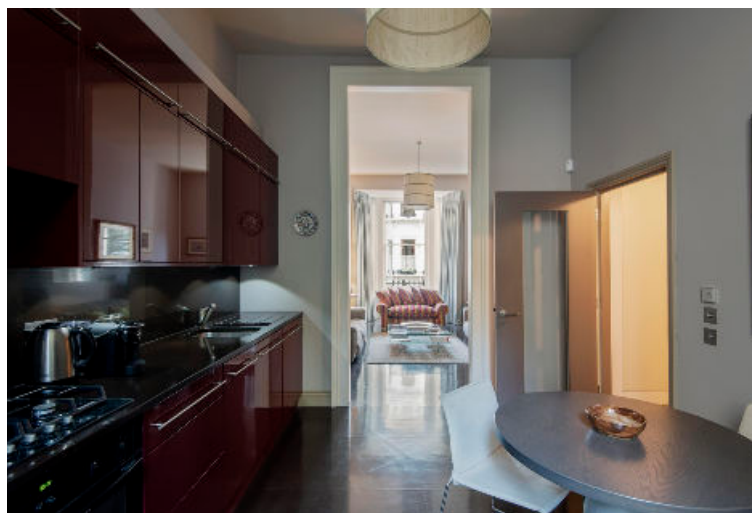

This apartment makes for the perfect first home, pied a terre or as a striking rental investment.



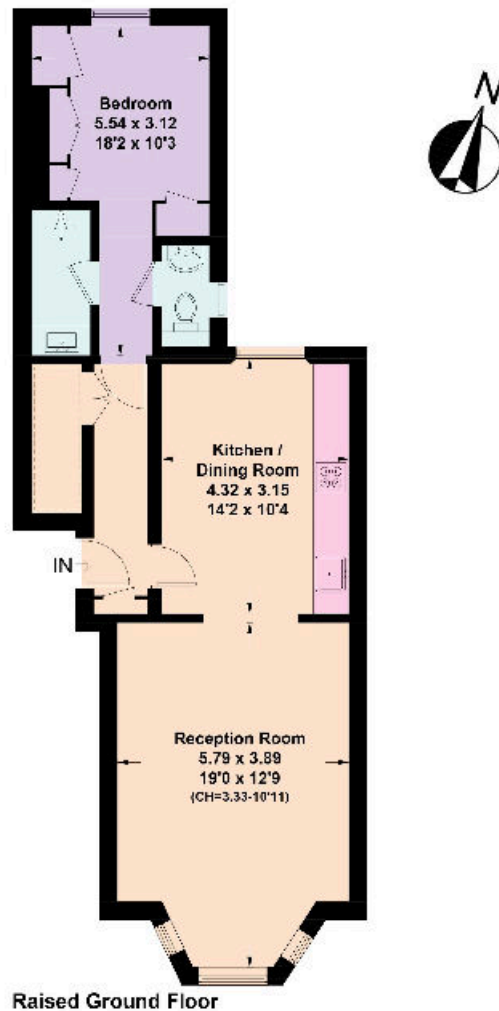
