














Location

Oakley Street leads from the Albert Bridge to the Kings Road, and is lined with a mix of white stucco townhouses and red brick mansion blocks.

Battersea Park is within walking distance, as well as the celebrated shops and restaurants of Chelsea.

The street has been home to numerous historical figures, including musicians like Bob Marley and David Bowie, the footballer George Best, the Russian spy Donald MacLean (one of the Cambridge Five), and the Antarctic explorer Robert Scott.




