



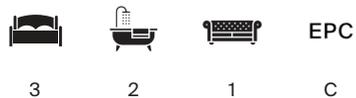

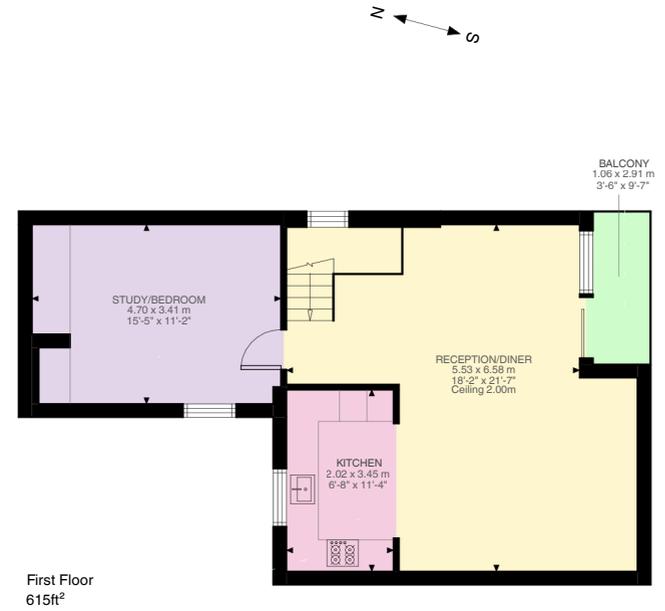

The ground floor comprises two well-sized bedrooms, each benefiting from its own en-suite bathroom and direct access onto a patio. The principal bedroom further benefits from having a dressing area. The first floor forms the main living and entertaining area, arranged around a large reception and dining room, with sliding glass doors onto to a balcony. The kitchen sits just off the reception area, continuing the open-plan flow of the space. A further room on this level - ideal as a study or additional bedroom - offers flexibility for home working or guest use. This unique apartment, with its combination of patio, balcony and mews setting, offers tranquillity while remaining moments from the amenities of South Kensington.
