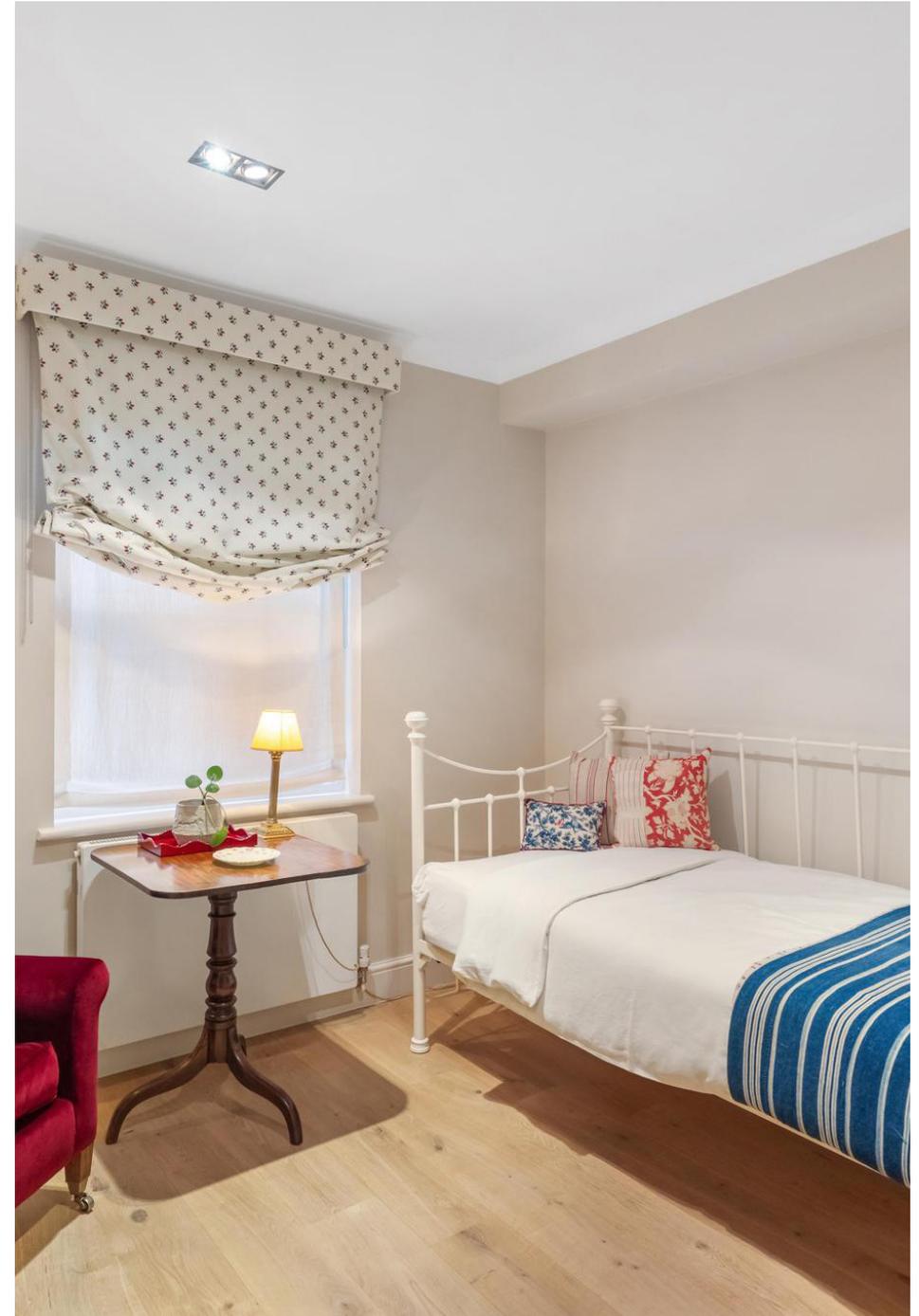

A guest cloakroom and excellent hallway storage complete the accommodation.

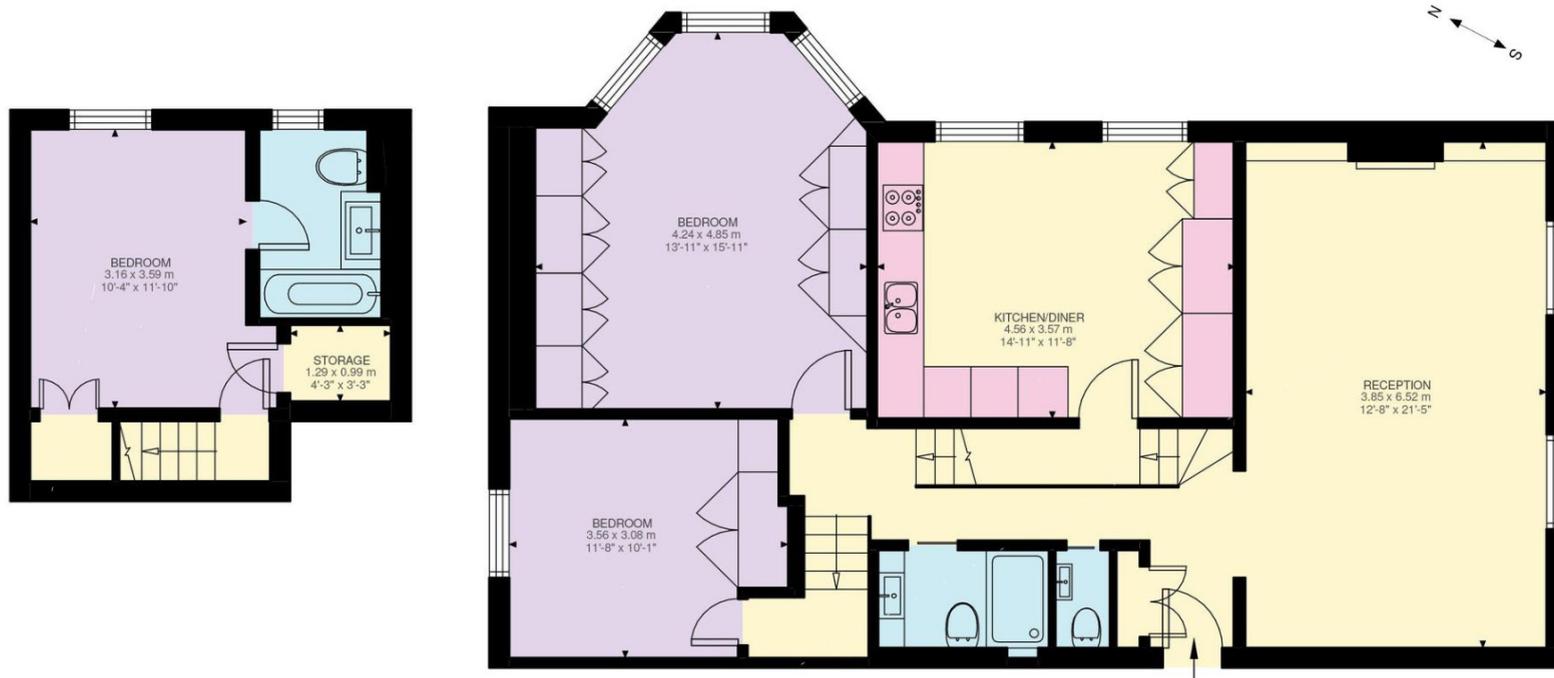
