

Park House, Swaines Hill, Pickaxe Lane, South Warnborough, Hampshire RG29 ISB

South Warnborough 2.5 miles: Alton 5 miles, Basingstoke 11 miles (London Waterloo 44 mins); M3 (J5) 7 miles: London (Hyde Park) 50 miles; Heathrow 36 miles (Distances and times approximate)

Park House is situated on Pickaxe Lane, a quiet country road on the crest of Swaines Hill. Swaines Hill is a small Hamlet located to the south of South Warnborough and few miles north of Alton.

South Warnborough is the nearest village, which has a pub (The Poacher Inn), a popular village shop, a post office and a 12th Century Norman Church.

This brand-new country house has been designed by Finchatton and Fowler Architecture and Planning in a traditional Georgian style. The new house is proposed to be arranged over three floors with an integrated double garage. In addition to the main house, planning has been approved for a second four-bedroom house and stand-alone garage and store.

From Junction 5 of the M3, proceed onto the A287 towards Farnham and Odiham. At the next roundabout take the right turning towards Alton, North Warnborough and Odiham on the B3349. Proceed through North Warnborough following the signs to Odiham and Alton. In Odiham turn right at the mini roundabout signposted to Alton and South Warnborough. Drive through South Warnborough and just after passing the hamlet of Blounce, turn left onto a country lane. Travel for about half a mile and at the T junction turn right onto Pickaxe Lane. Park House is located on the left.






