Situation

Chedworth is set in a beautiful valley within the Cotswold Area of Outstanding Natural Beauty. It has a pre-Norman church, a village school, a 17th-century pub, a village hall, a cricket ground and a football pitch. Local shops are in Northleach, with Cirencester providing a range of shops and services, including a large Waitrose, weekly markets and a monthly farmers' market. Cheltenham is within easy driving distance with a wider choice of shops and recreational and cultural facilities. The A419 dual carriageway at Cirencester provides easy access to J15 of the M4 at Swindon, and the A40 at Northleach provides links to Cheltenham and Oxford. There is an extensive network of footpaths and bridleways in the area. Polo at Cirencester Park; golf courses at Cirencester and Burford; racing at Cheltenham and Stratford on Avon; with theatres at Cheltenham and Oxford. The area is noted for its private and state schools, including Primary schools in Chedworth and Northleach. Some of the schools are The Cotswold School, Rendcomb College, Hatherop Castle, Beaudesert Park, Westonbirt, Cheltenham College, Cheltenham Ladies' College and Dean Close.








The Property

Holmlea and Green Close are beautiful examples of conjoined Cotswold stone village cottages formally used for multi-generational living. The house could either be kept as two separate dwellings, with potential rental income, or subject to the relevant permissions, be rejoined to create a stunning large family home. On the ground floor, the properties are separated due to the multi-generational needs of the current owners. However, the property is interlinked through an upstairs bedroom, suggesting the property could be returned to a single home, subject to the relevant permissions.




