A unique property that must be seen is quite unassuming from the front of the property but offers an abundance of natural light and lateral living space that local period houses don't offer. The ground floor comprises one single bedroom, a double reception room, a downstairs WC and utility room and a separate eat-in kitchen dining space complete with a kitchen island focal point. The double reception room benefits from wooden flooring, plentiful storage, and internal doors to allow a flexible living space which could be converted into a ground floor bedroom. The kitchen is spacious and is fitted with modern appliances (including a dishwasher) and the reception room has easy access to the pergola covered patio courtyard to the rear. The first floor is well laid out with built in storage, two bathrooms and that feeling of lateral space again.


