

The entrance hall leads to the left to a formal, double reception room at the front of the house with a fireplace, bay window and ceiling moldings. This room has fantastic proportions and is flooded with natural light. To the rear of the ground floor is the expansive kitchen family room with a bespoke kitchen with high units. The full width bi-folding doors lead you into the landscaped garden at the rear.

The principal suite is on the first floor, with ample fitted wardrobes and a large ensuite bathroom. There is a further bedroom to the rear overlooking the garden as well as a family bathroom
