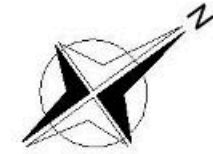
Step outside through the sliding doors from the kitchen and you will find a quaint courtyard garden, perfect for enjoying a morning coffee or al fresco dining in the evenings.



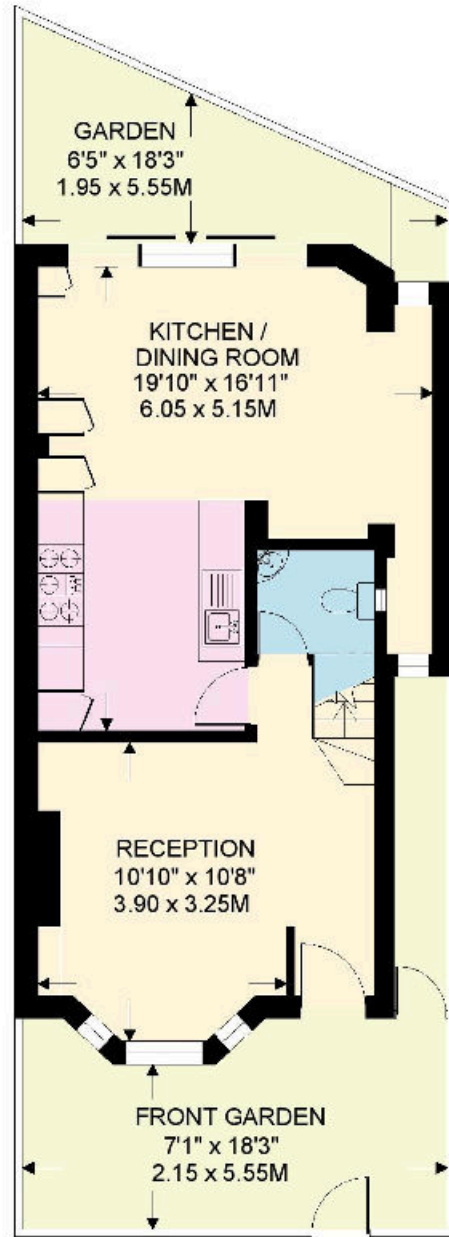

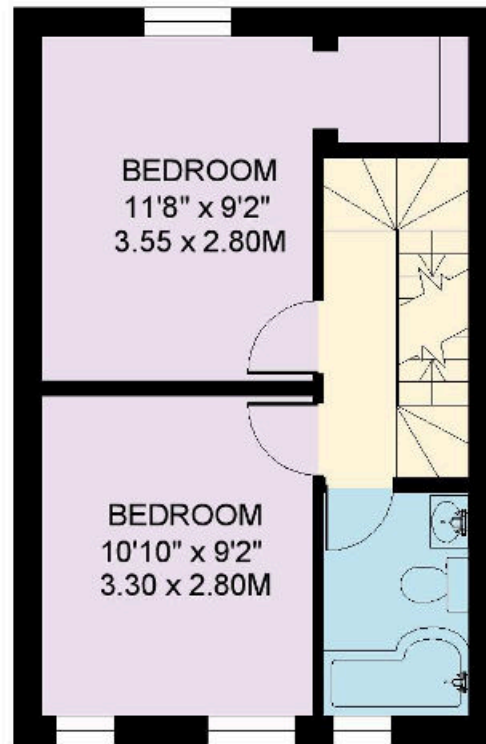

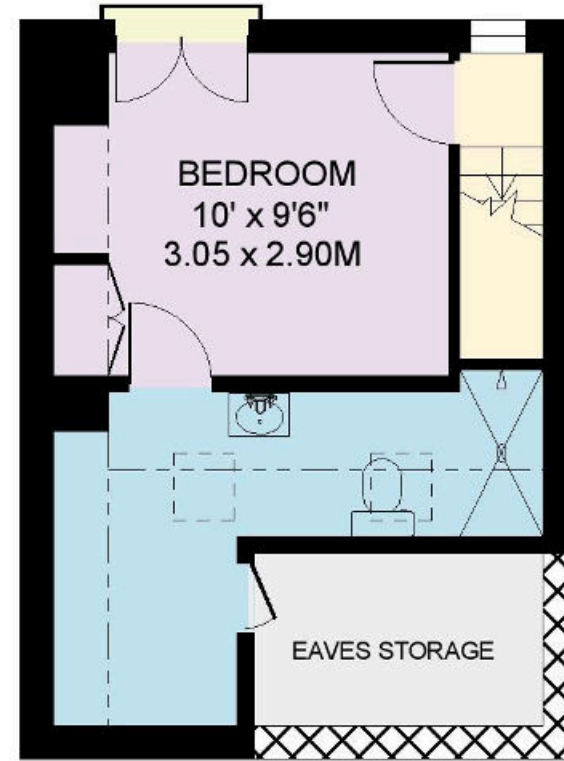
