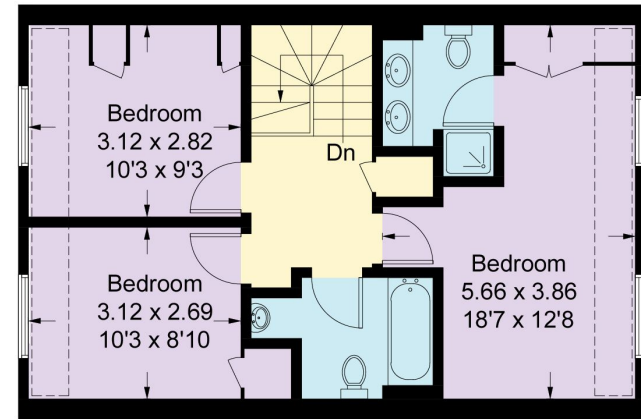
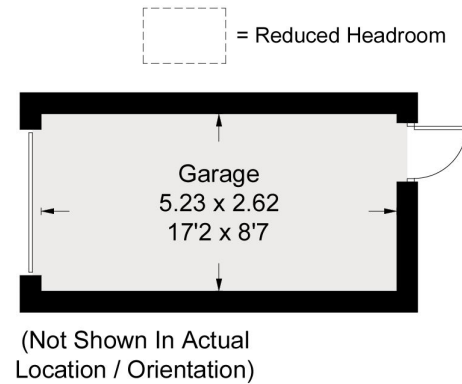
Ditton Reach is a fantastic location. Thames Ditton and Surbiton train stations are about a mile away and the River Thames is on the doorstep.



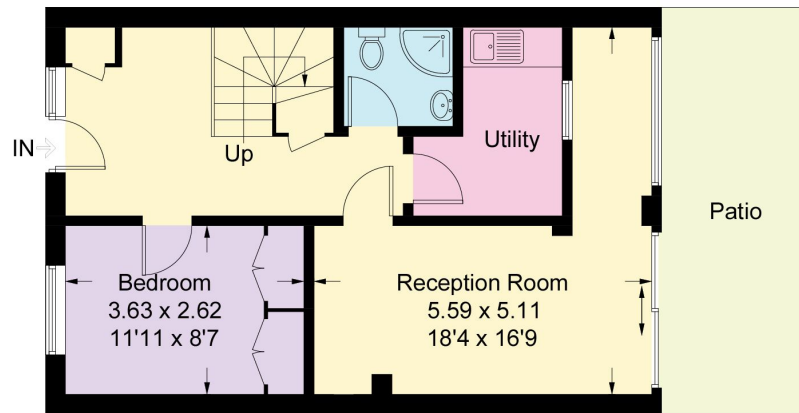

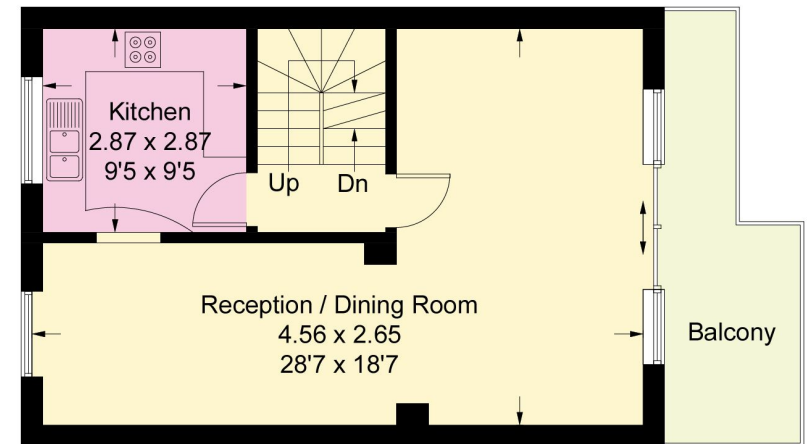
