



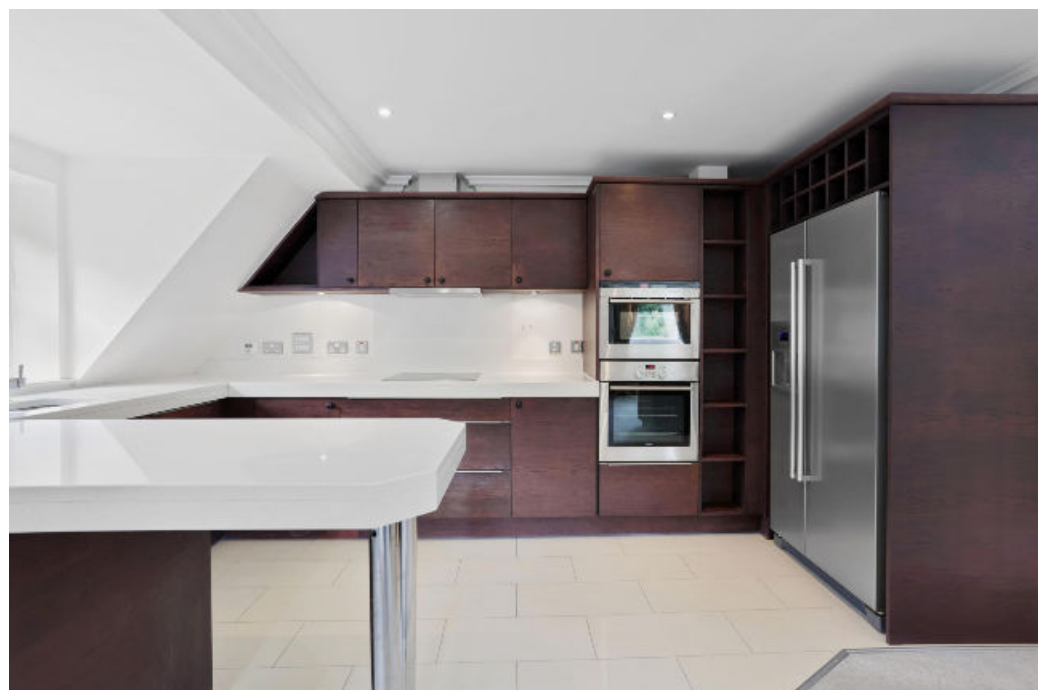

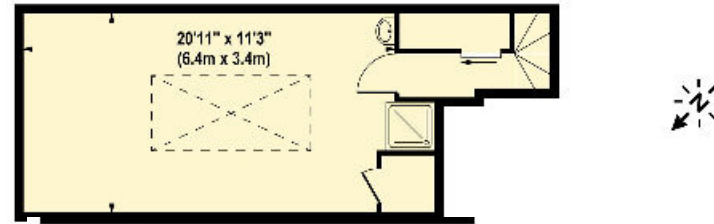
Location

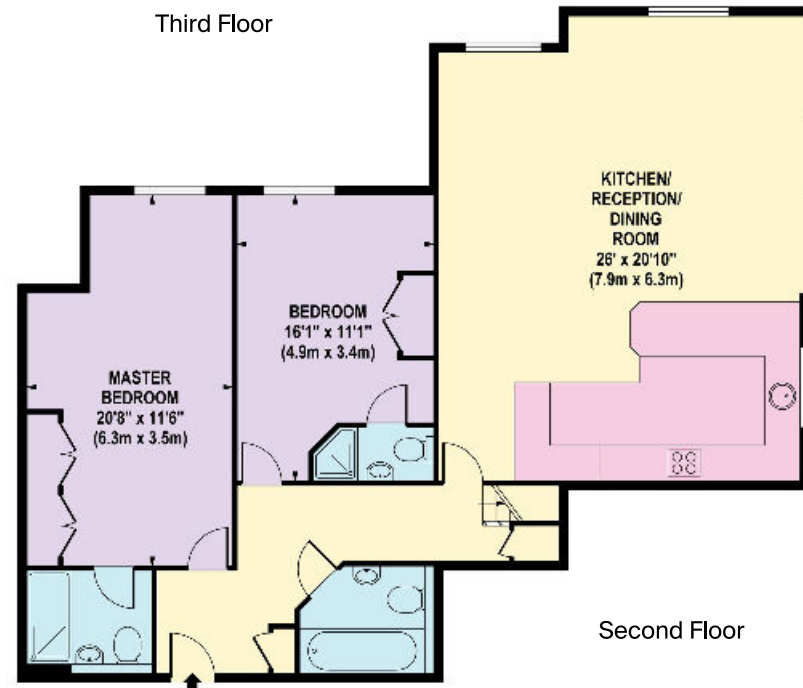




Third Floor
