




## Further rooms

The second floor has 2 en suite bedrooms and a further two bedrooms. The second floor also has a large family bathroom featuring a shower and a free-standing bathtub.














The village has the usual High Street chains and a nice collection of village shops: butcher, greengrocers, baker etc. Restaurants. Epsom and Sutton provide more in the way of shopping and entertainment. There are five schools dotted around the village, including two private schools, Green Acre for girls and The Priory for Boys.

The outskirts of Banstead has garden farms, garden centres and some lovely Green Belt countryside, notably Banstead Commons and Banstead Woods. Banstead Woods Estate, a site of special scientific interest, has a wide variety of flora and fauna. There are lots of stables in the area and plenty of opportunities for those interested in riding or walking. Banstead Leisure Centre includes Gym, Swimming Pool, Squash and Tennis Courts and there are also local Cricket, Football and Rugby Clubs. The area is also well served with golf courses, including Cuddington, Banstead Downs, Walton Heath, Kingswood, Oaks Park, Reigate, Chipstead and Epsom. Epsom Racecourse is within easy reach if you fancy a flutter on the horses. The nearest railway stations are located at Banstead and Chipstead, and the M25 motorway is also located nearby






