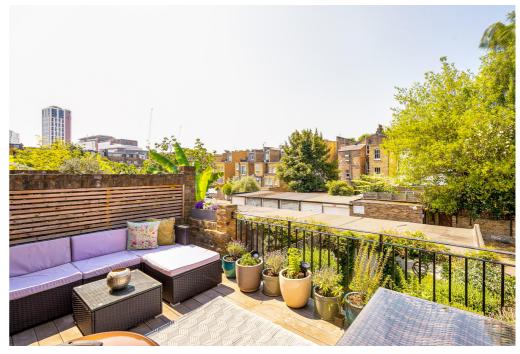




The ground floor accommodation comprises; a double reception room and a fabulous open plan kitchen/dining room that has been fitted with an array of units and central island. To the rear is the south facing garden with adjoining single garage that is accessed via electric private gates.

The first floor provides the principle bedroom with a dressing area and en suite. Adjacent to this is the bedroom/home office with a bathroom and access onto the sunny aspect roof terrace. There are further three bedrooms and two bathrooms on the second and third floor.

pubs and the superb Sonya cafe. The River Thames and Chelsea Harbour
are close by.

Fulham Broadway (District Line) is the closest underground station, and there is a choice of bus routes leading to and from the West End. West Brompton Station with its link to the Overground is also nearby. At the end of Rumbold Road on the Kings Road is a bus stop where the 22 and 11 bus travel into Chelsea and Central London.
