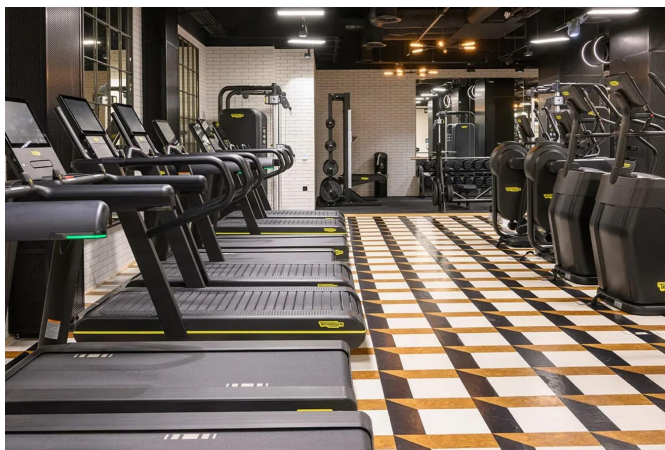

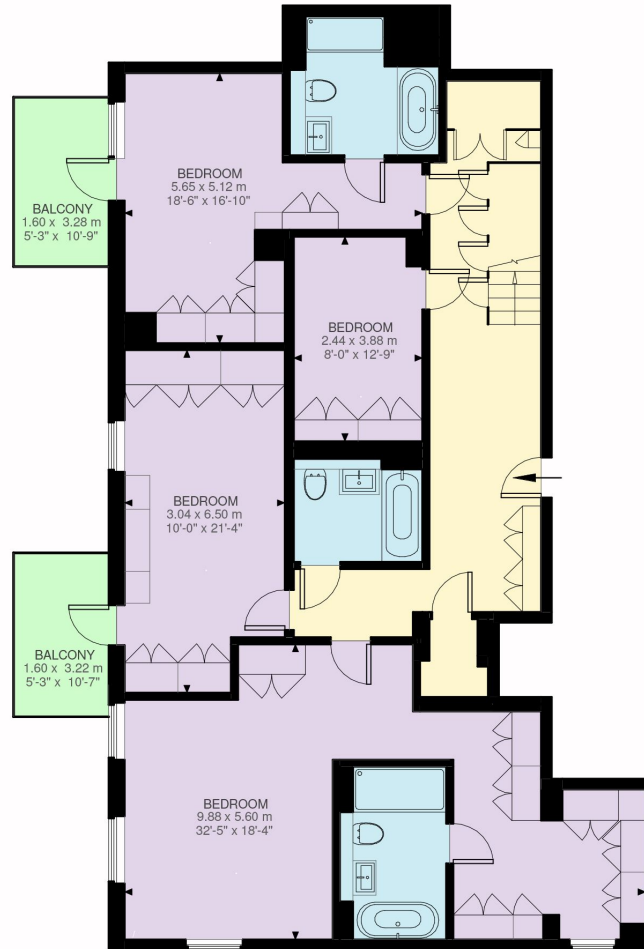

In addition the property has underground secure parking.

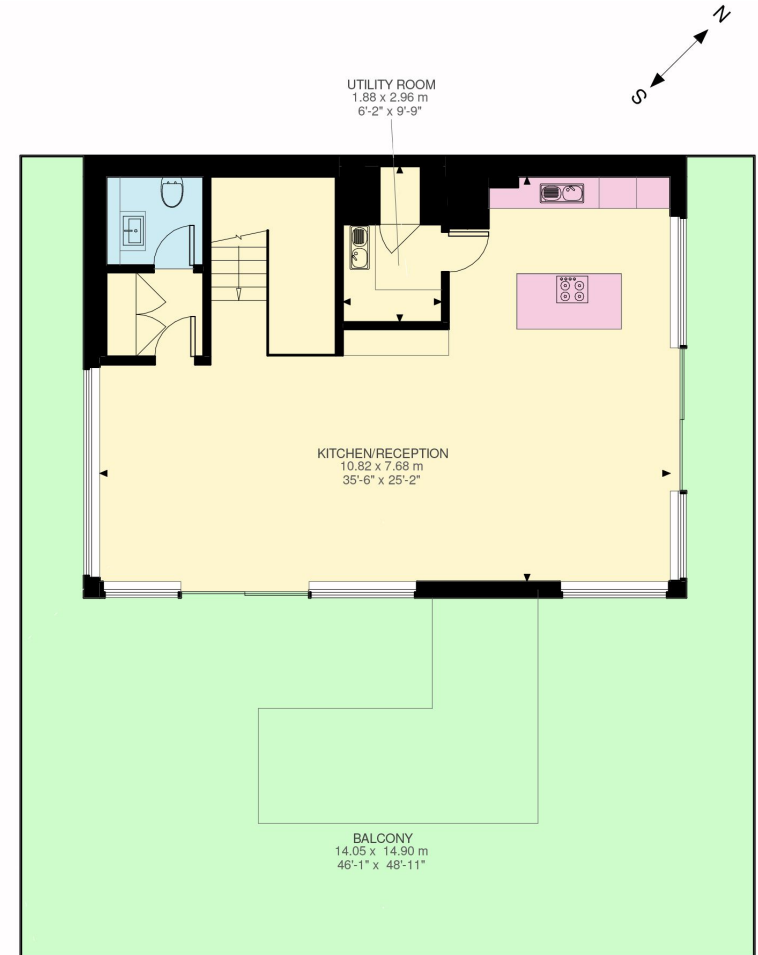
