

# Ongar Road, Fulham SW6





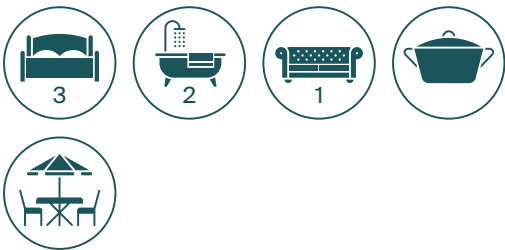
A beautifully presented three bedroom apartment in a prime location on Ongar Road, SW6.

The property has been recently refurbished to a very high standard and is available to rent unfurnished.



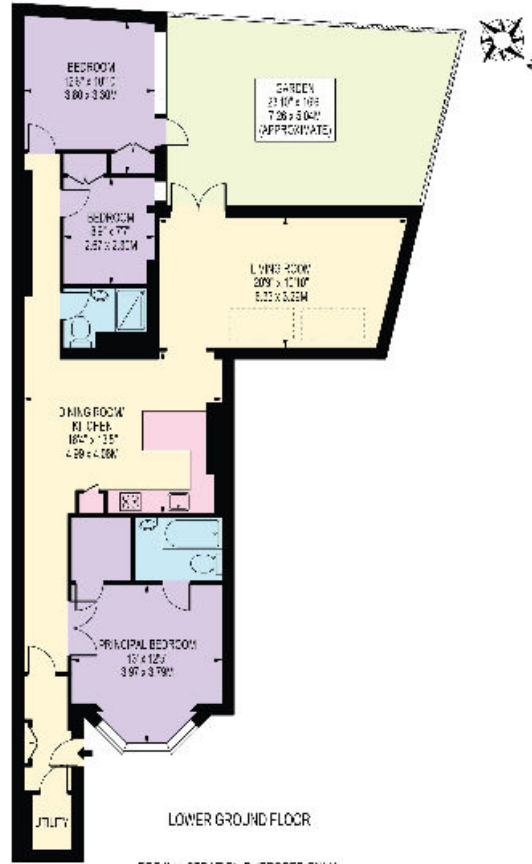
