On the first floor there is a sizeable, bespoke kitchen diner with feature marble island, a double reception with bespoke joinery and two fireplaces as well as a terrace.





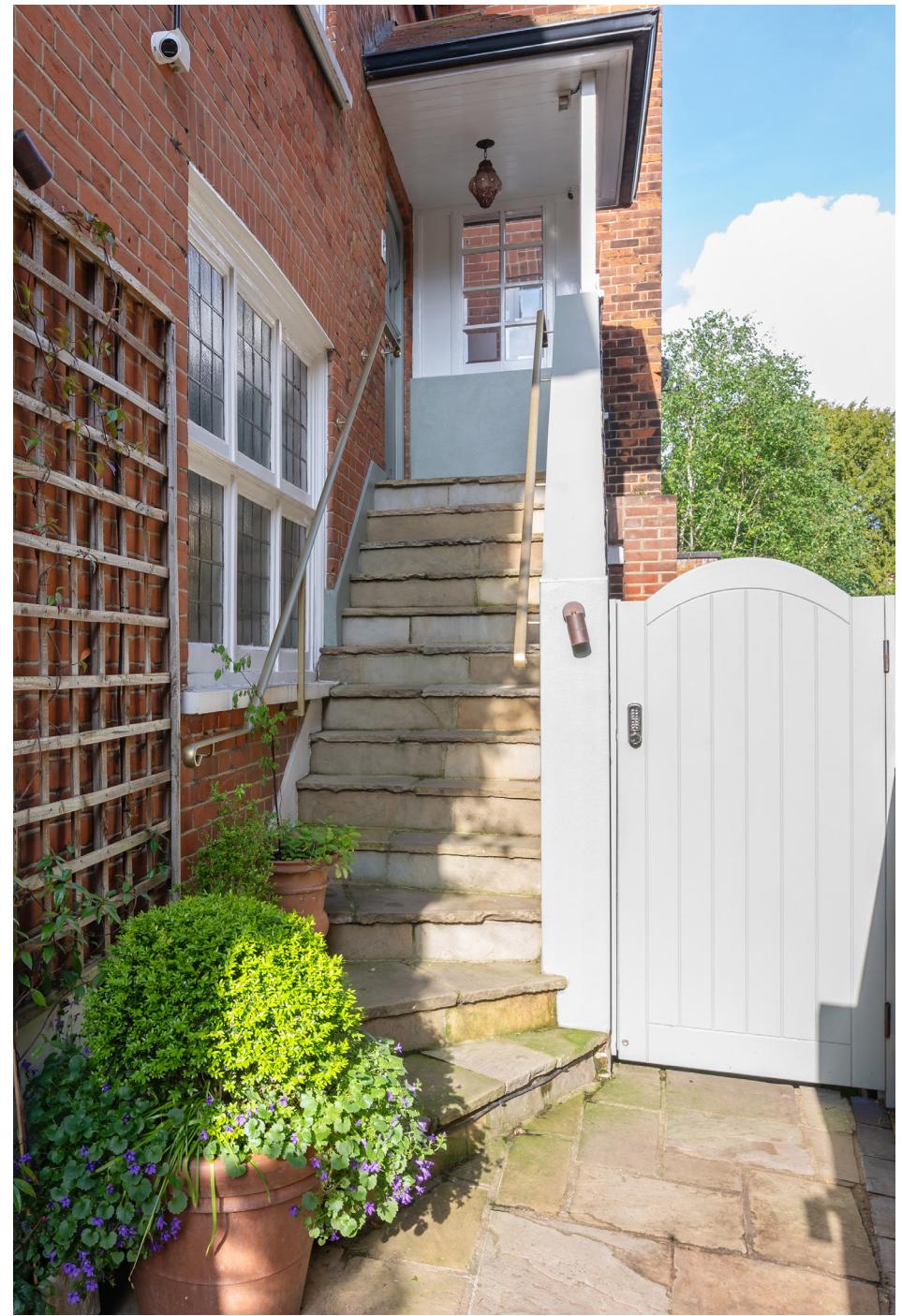

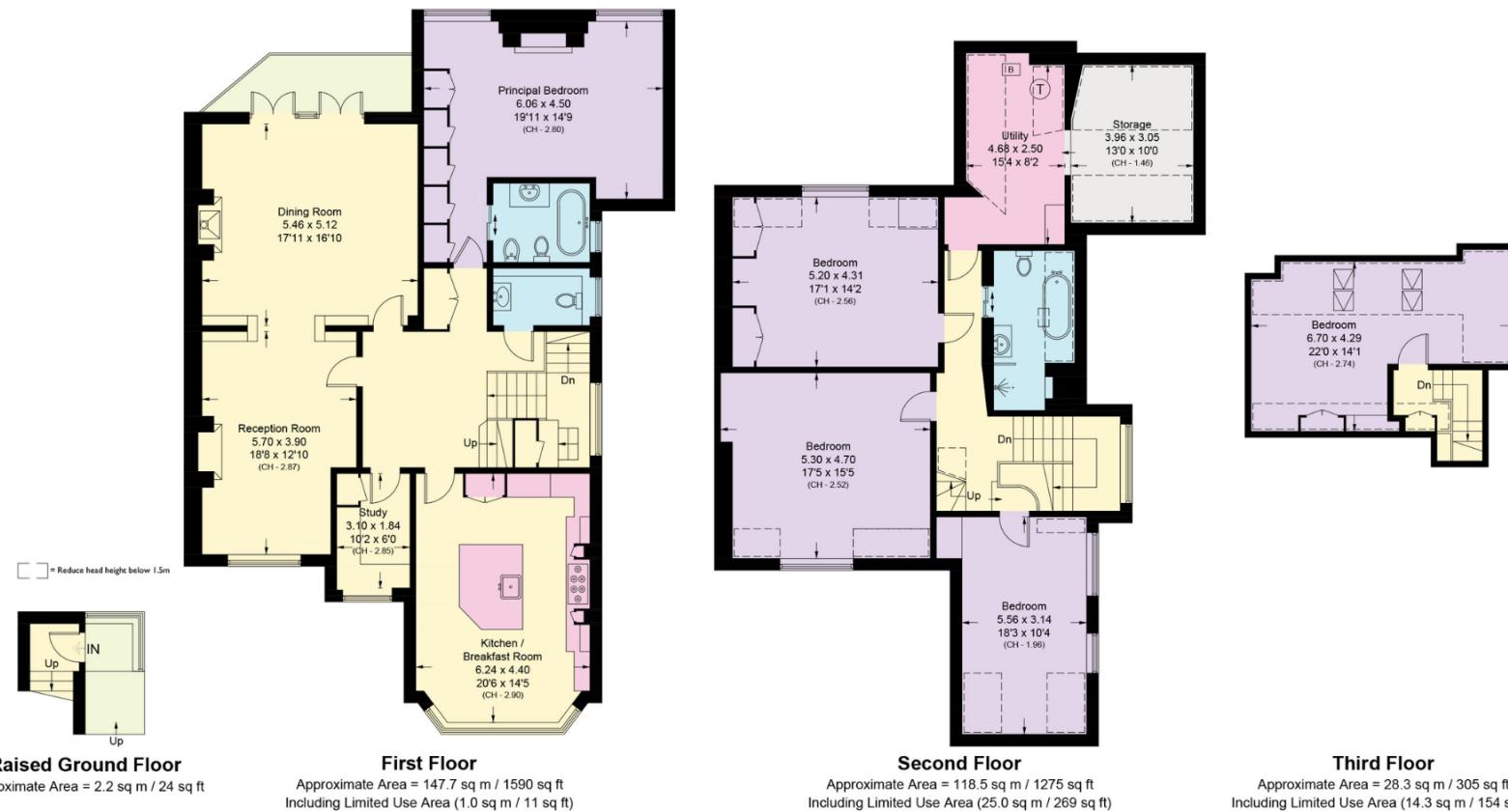
