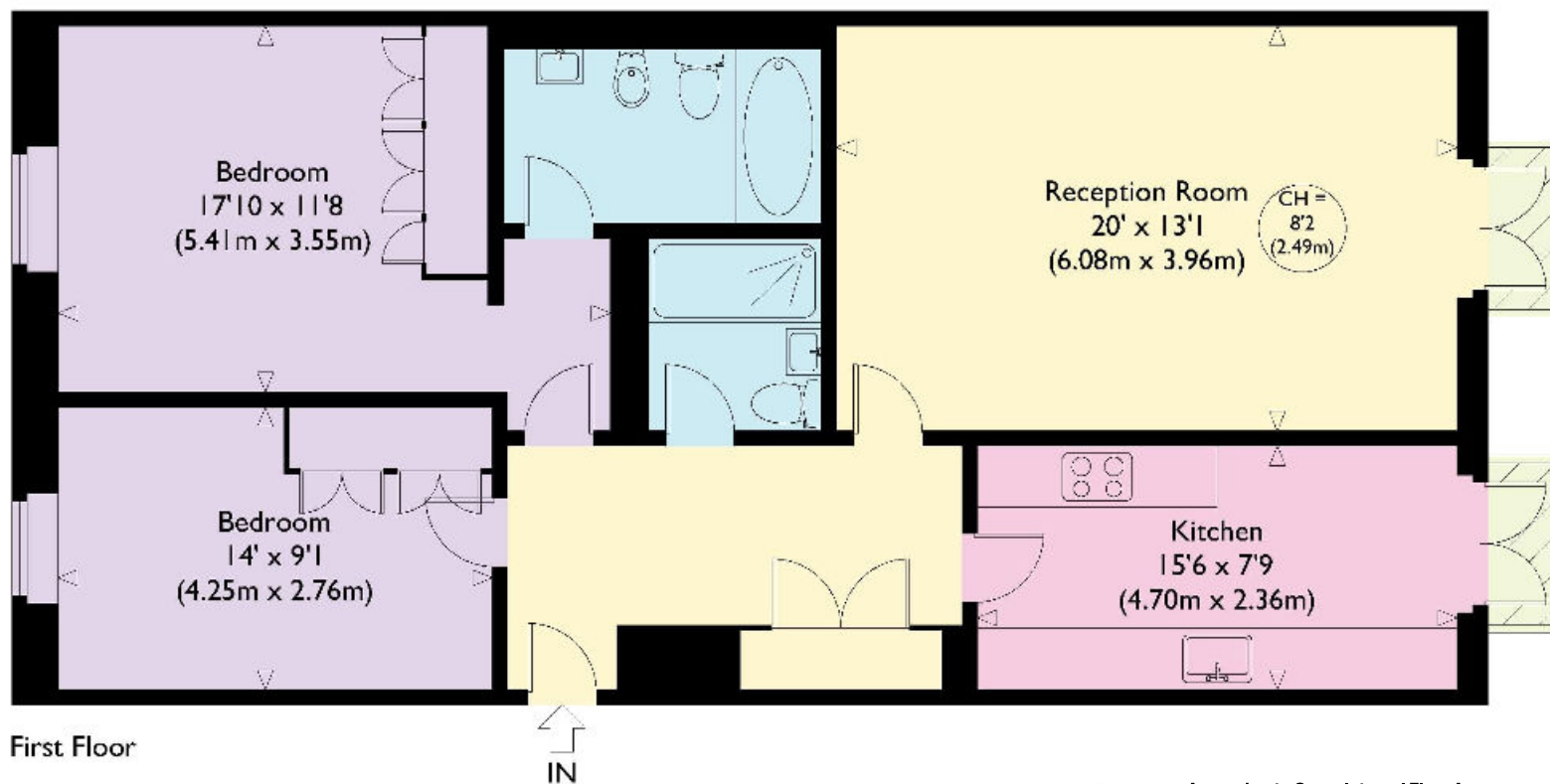
Location:
