## Location

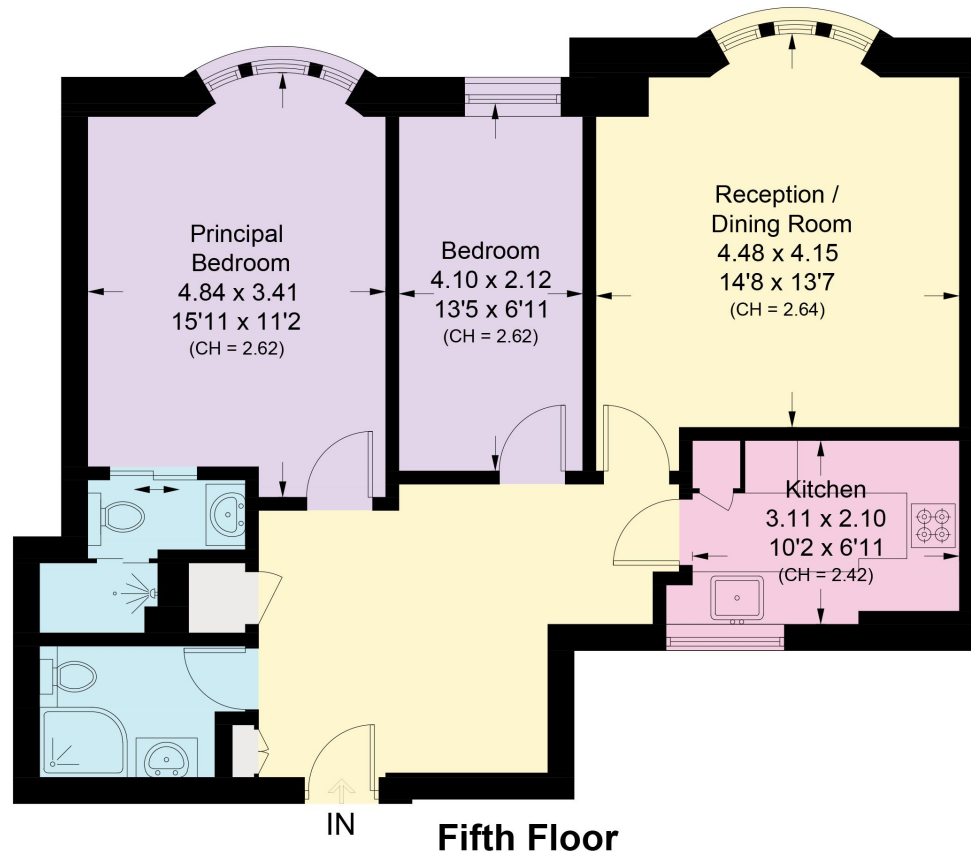
