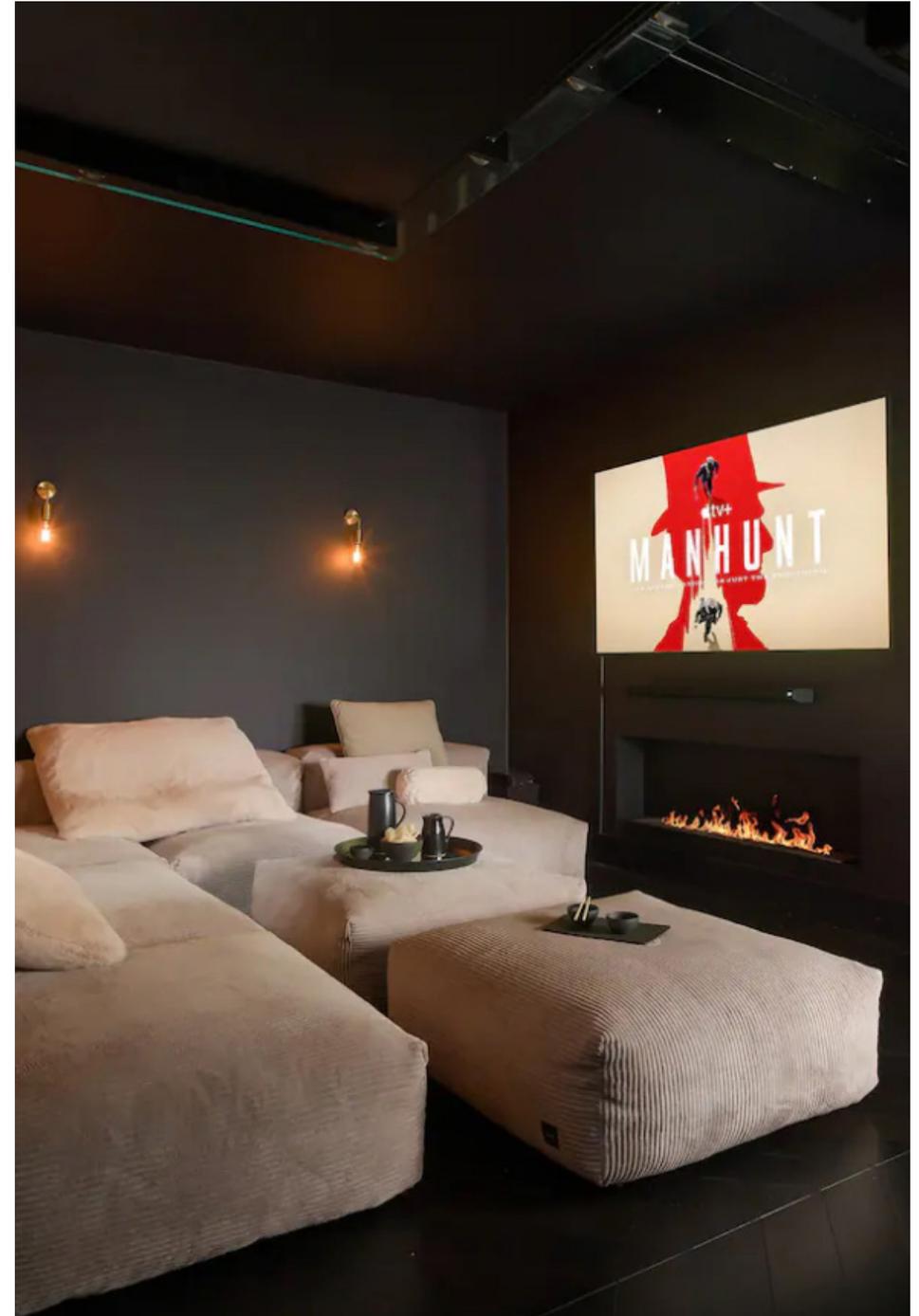


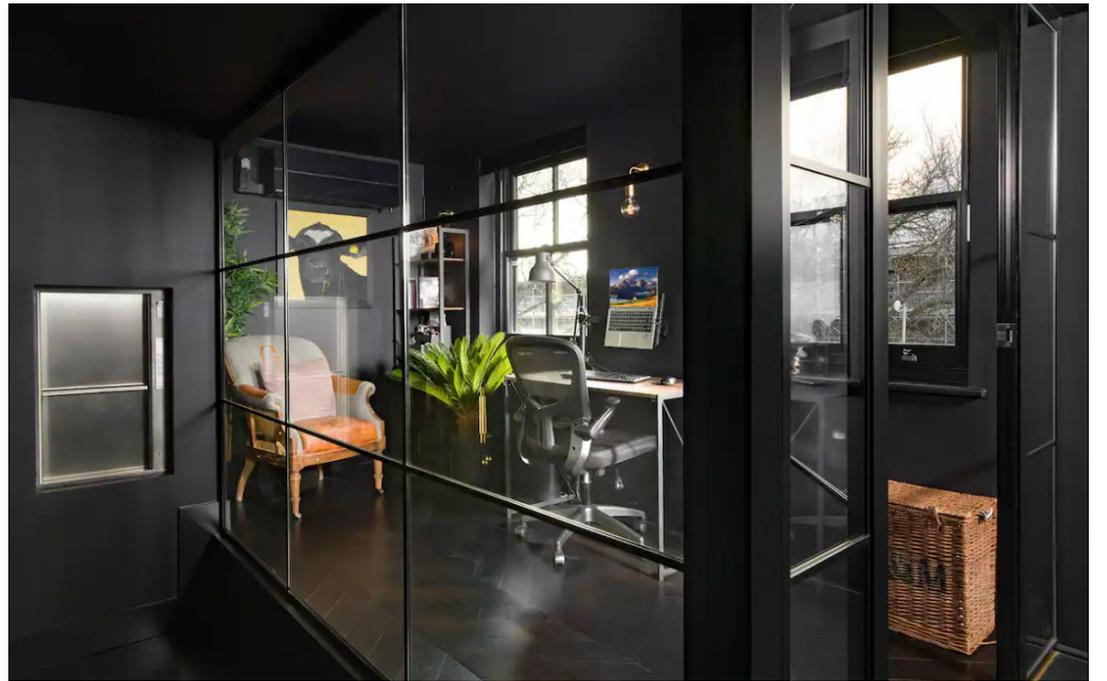
The ground floor provides an open plan reception room with a hand made, wooden kitchen by The Main Company that boasts breakfast bar, Miele appliances, Bora induction hob with teppanyaki grill and wine fridge.

The lower ground floor offers a flexible second reception space, currently being used as a cinema room whilst there are also a utility room and shower room found on this level.

Access to the first floor is via the beautiful centre piece floating staircase, past exposed brickwork and crittall windows, where you will find two double bedrooms both featuring built-in storage, home office and a further shower room.

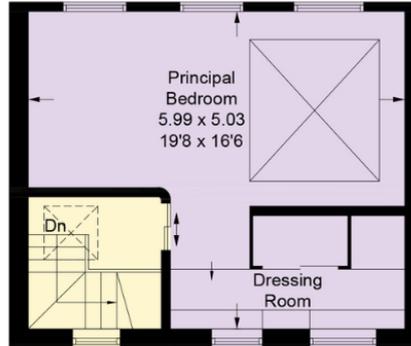

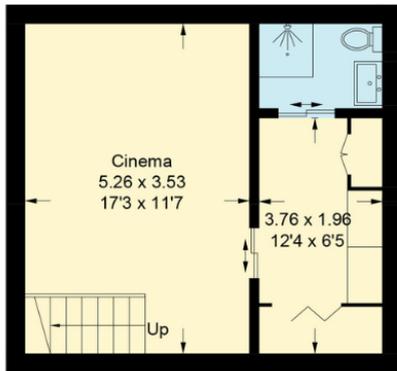

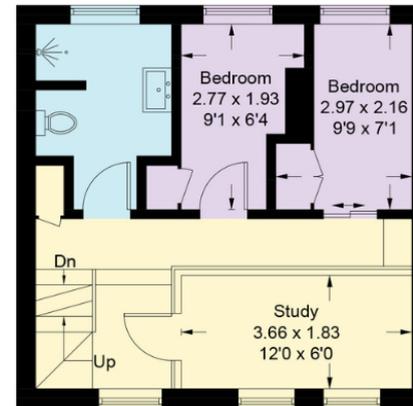
**Lower Ground Floor**
