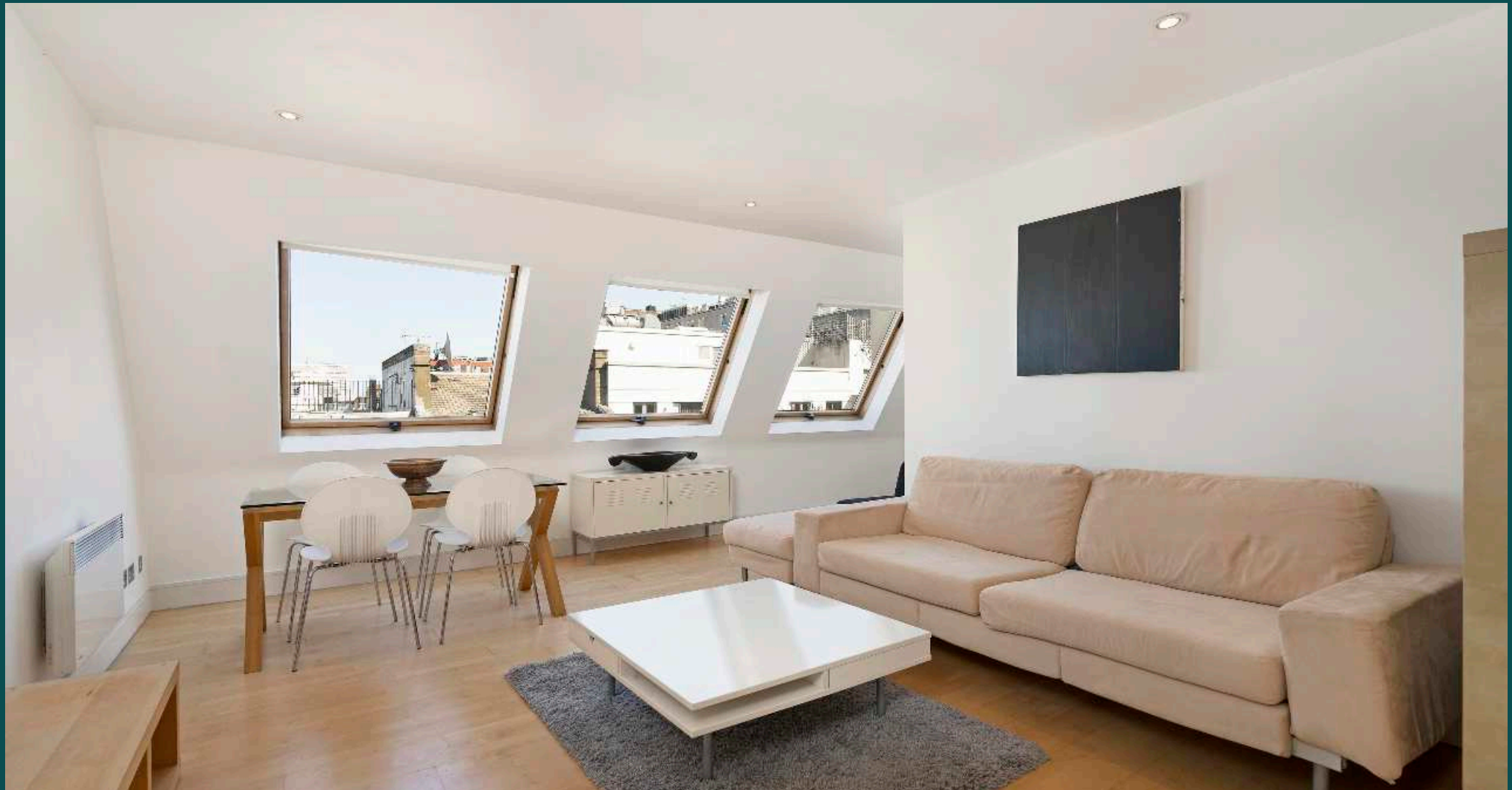

A charming one bedroom apartment to rent in Queensborough Terrace, W2.

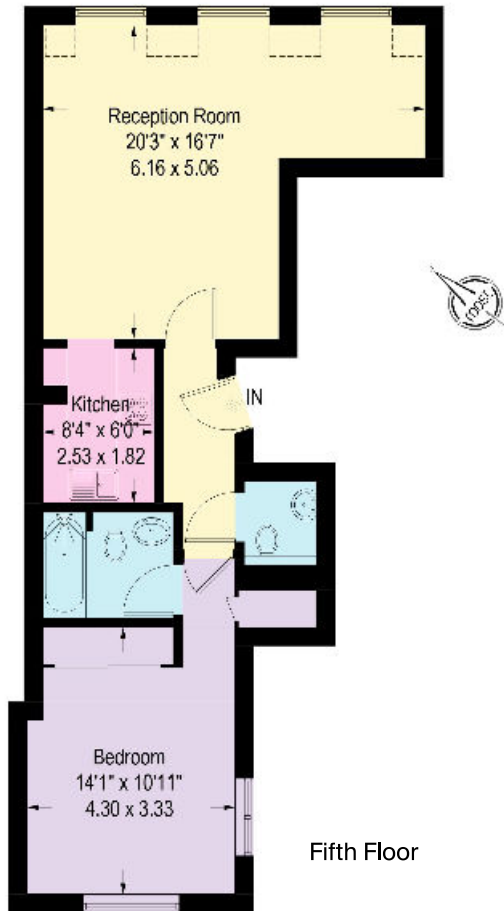
