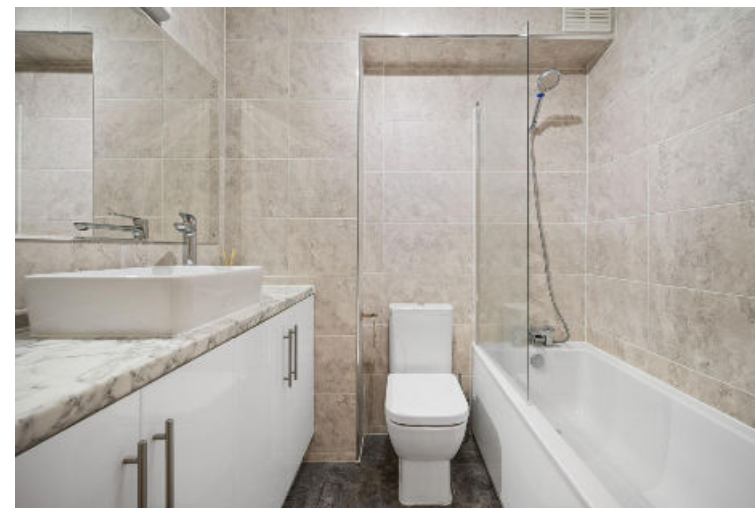


Craven Lodge, Craven Hill W2

The property also benefits from its own garage space located to the rear of the property which is available through separate negotiation.

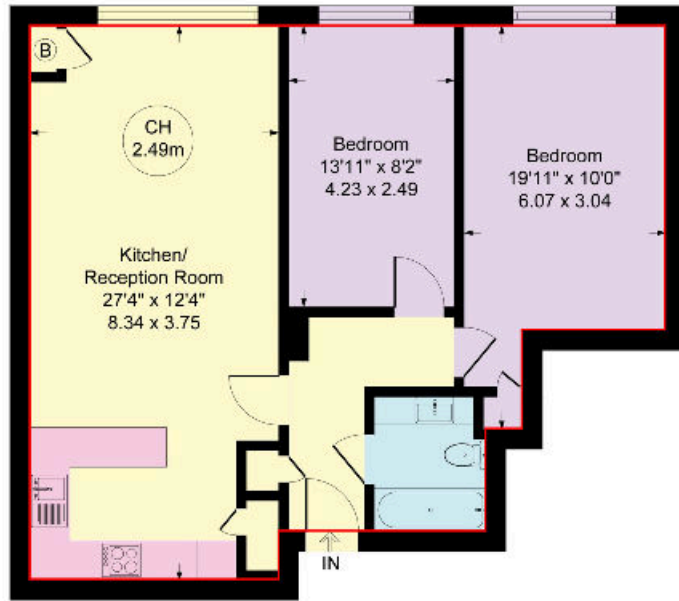

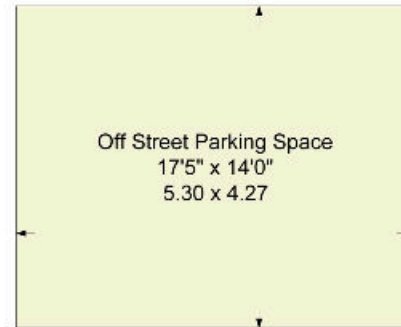
