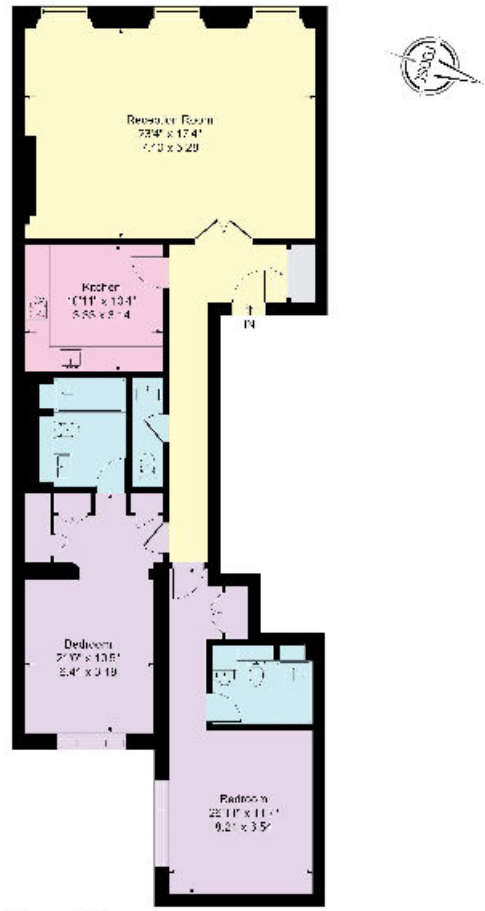
Set on the second floor of this attractive white stucco-fronted building, this apartment has been recently refurbished to an exceptional standard with wooden flooring throughout.
