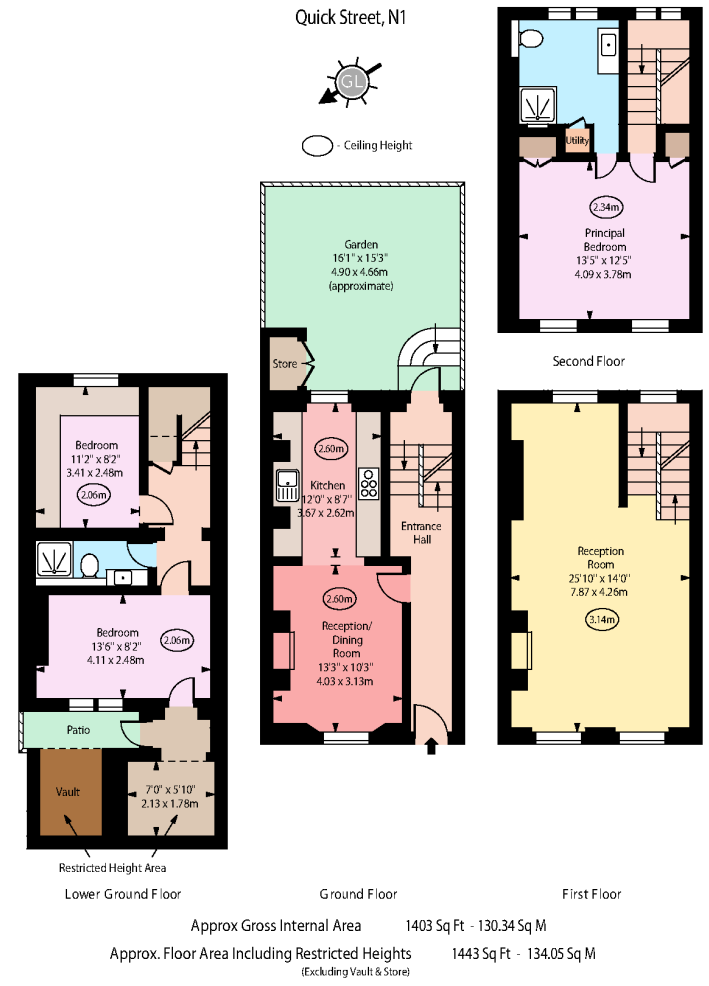


Location
