The property is parallel to Wright's Lane and close to Kensington High Street with all its shops, restaurants and other amenities.

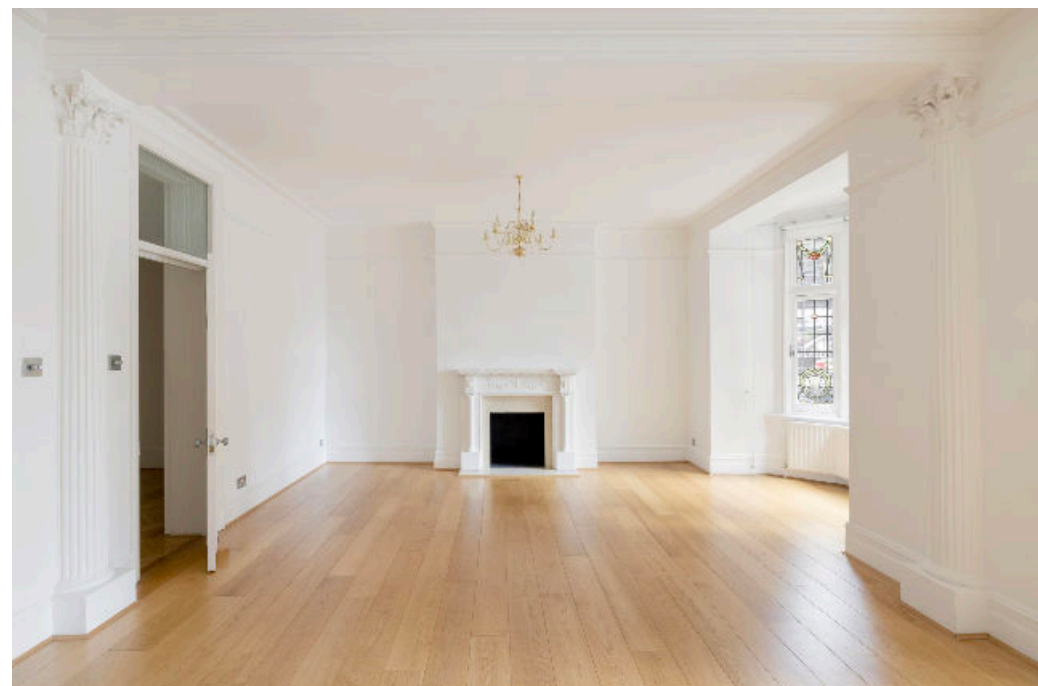
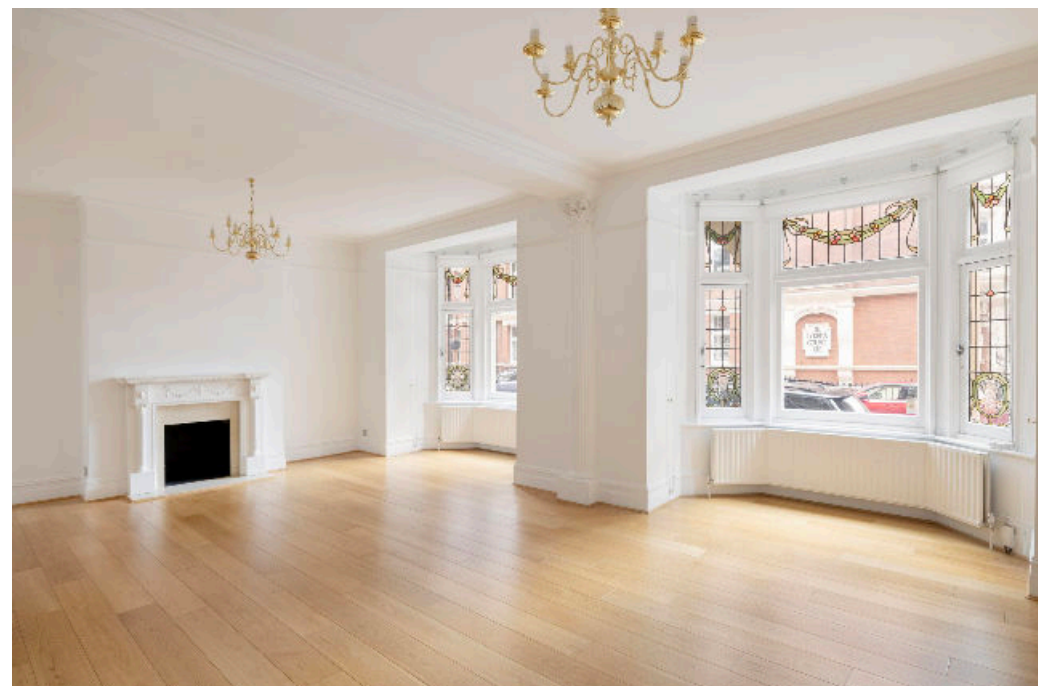

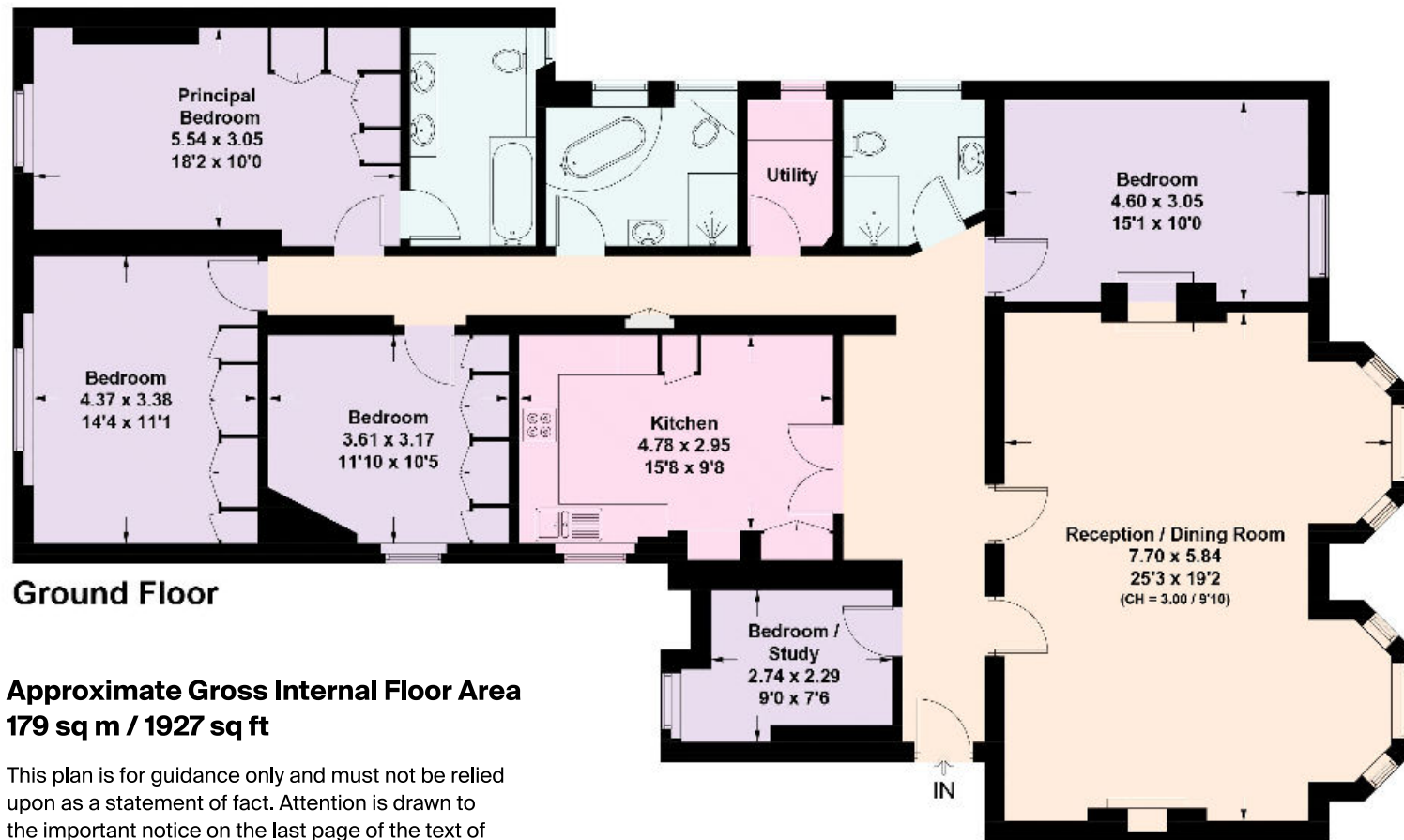
