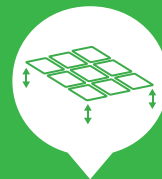

## Location

1 Sterling Court is prominently located fronting Dewsbury Road (A653) at the entrance to Capitol Park East adjacent to Junction 28 of the M62 motorway and approximately 6 miles South of Leeds City Centre.

Capitol Park is strategically located providing both unrivalled access to the main northern motorway network (M62 and M1) and the nearby White Rose Shopping Centre, with well-served public transport links.

Capitol Park benefits from a De Vere Village hotel with Village Health and Wellness Club at the entrance to Capitol Park West with other amenities including conferencing, leisure and gym facilities, a Starbucks and restaurant facilities.

## Rates

1 Sterling Court will need assessing for rating purposes on occupation. The previous rateable value (May 2017) was £162,000.
