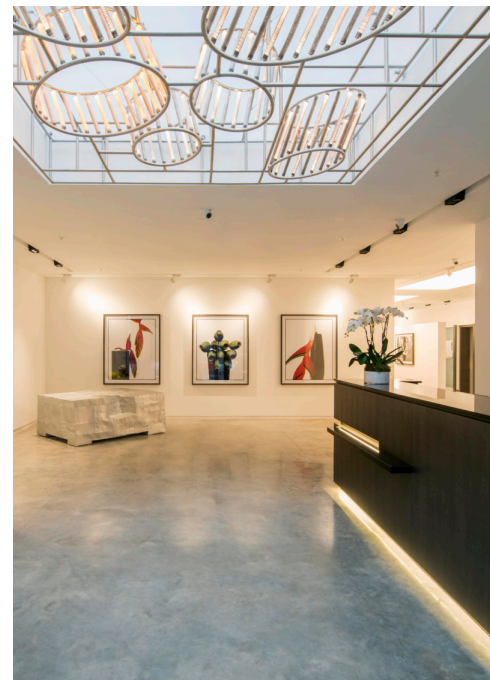




Amenities

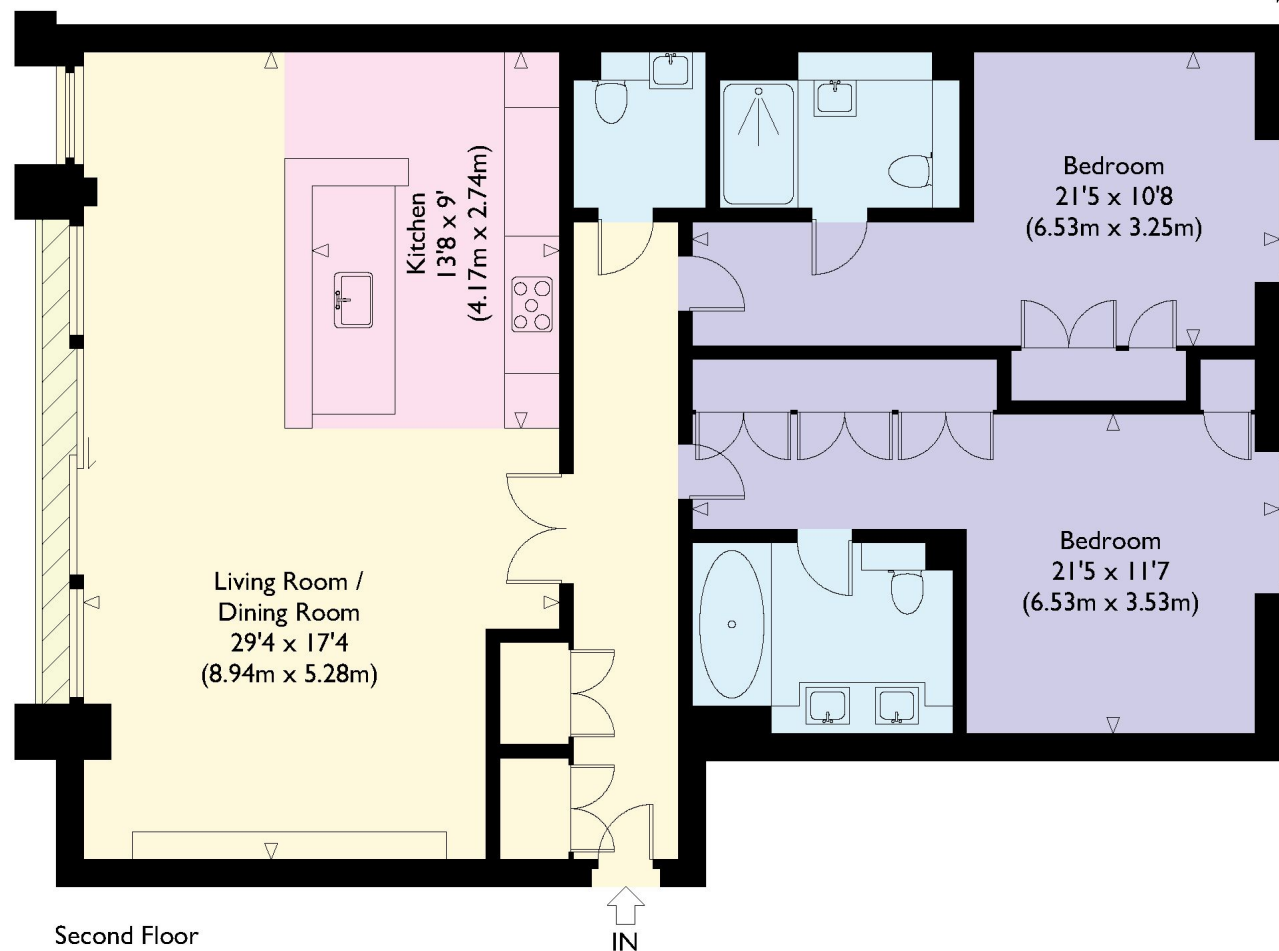
