General Leith was commander of Duke Wellington's 5th Division in the Anglo-Portuguese Army at several critical battles during the Peninsular War between 1810 and 1813, and General Edmund Stevens, commander of the 65th regiment of foot between 1797 and 1814, both lived in the building in 1813.



















