There are two bedrooms that both share the family bathroom located off the reception room.

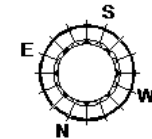
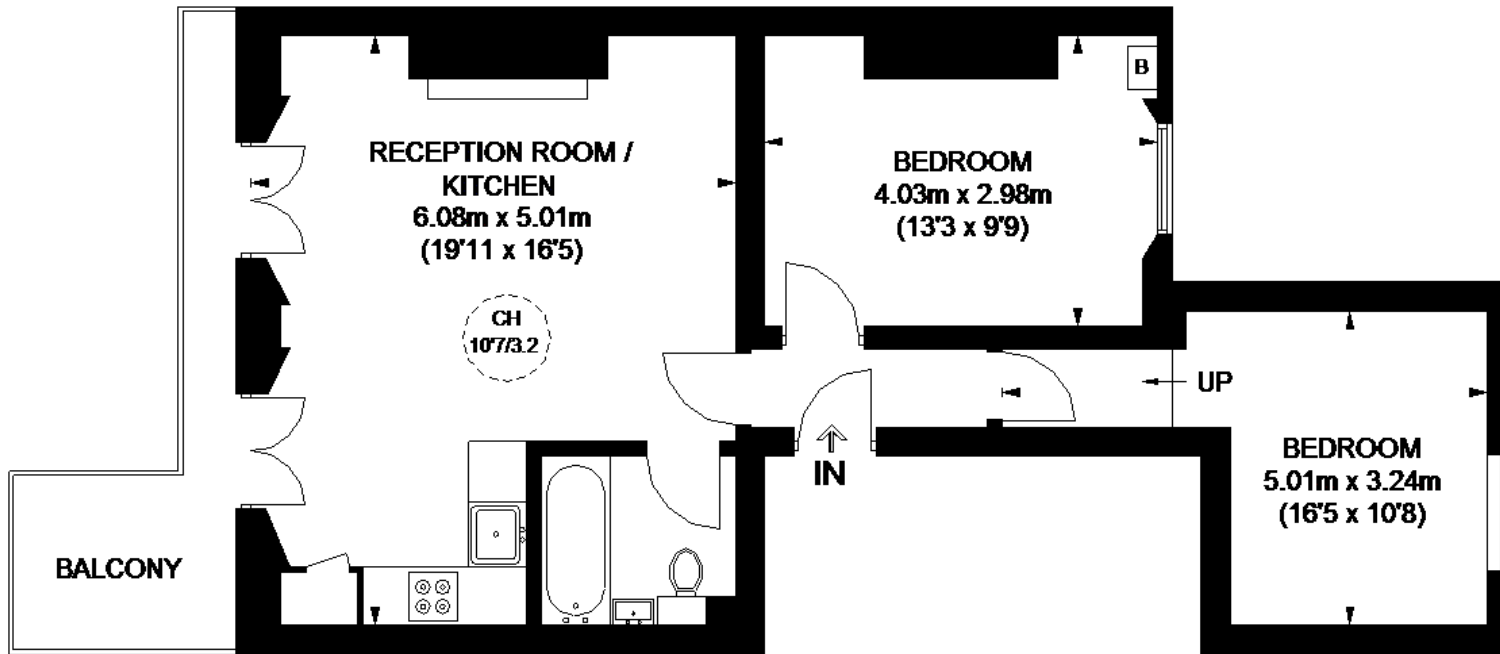
Throughout the apartment there are large windows allowing for natural light to burst through, creating a light and airy feel.



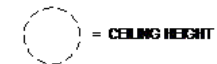
