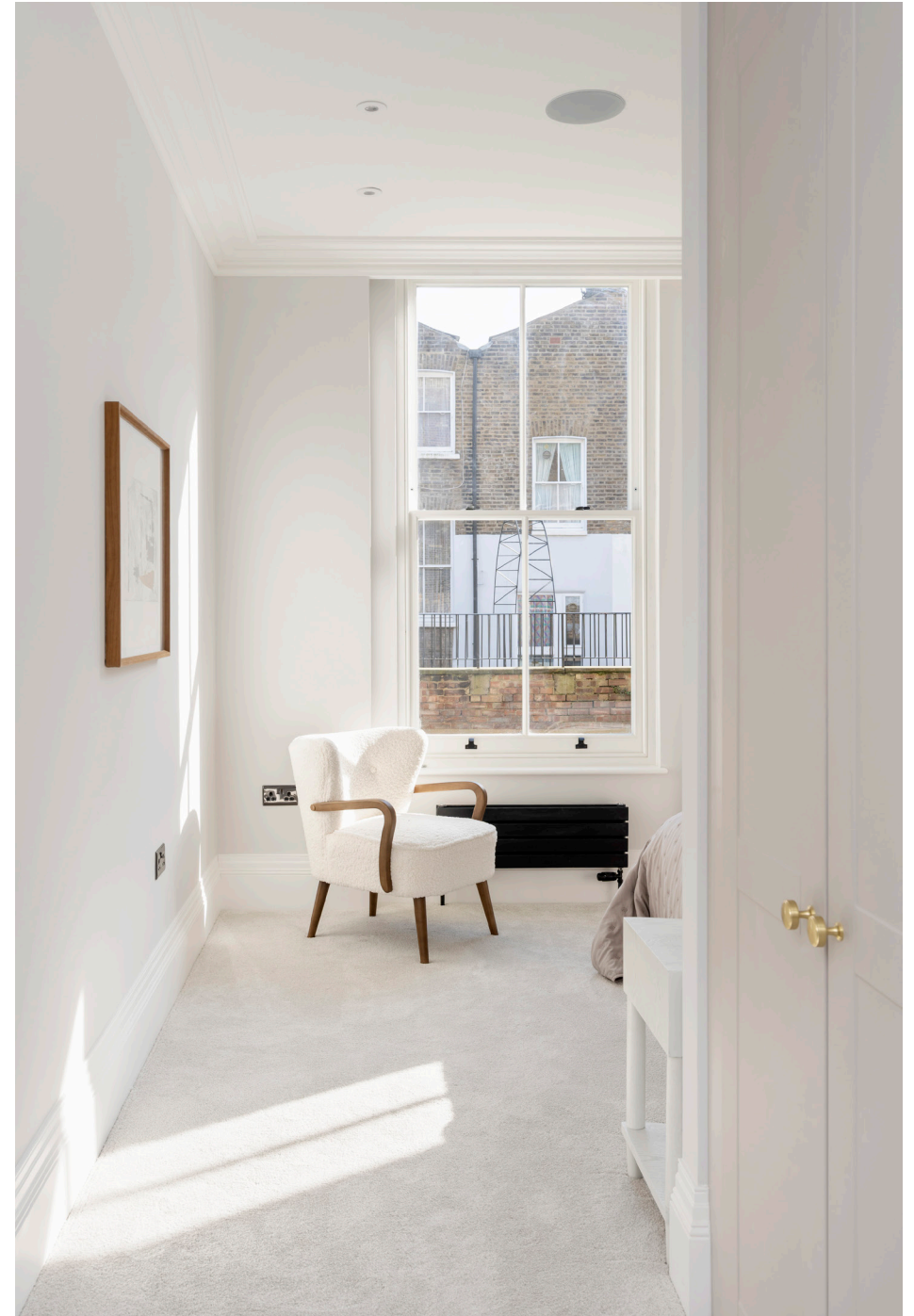

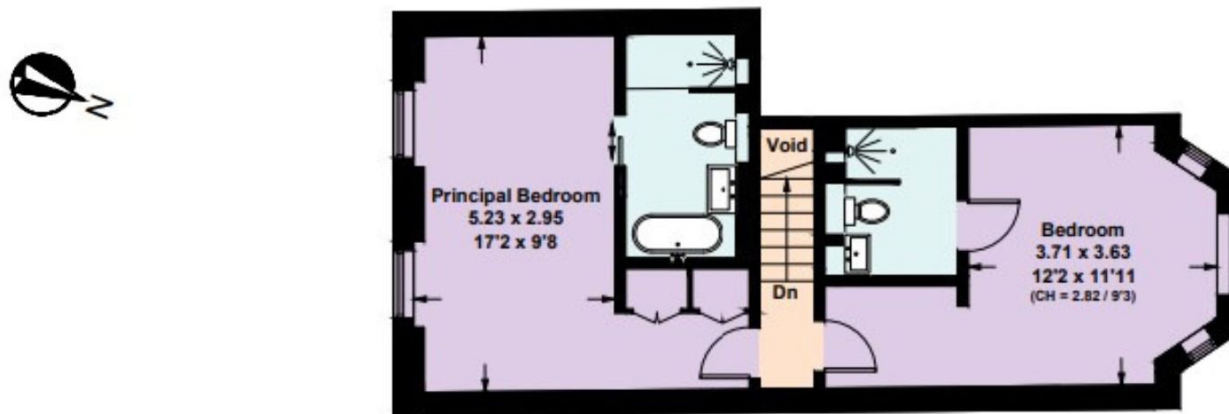

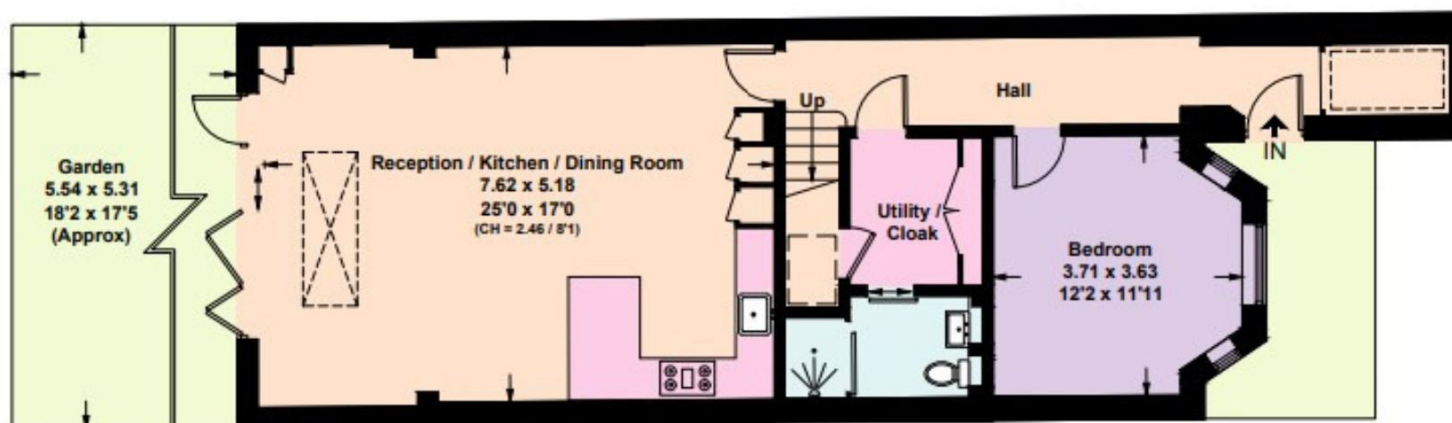






First Floor
