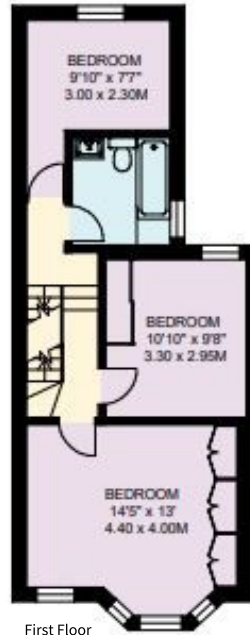
The first floor provides three bedrooms, two of which are double in size with fitted wardrobes and a family bathroom. On the top floor is another double bedroom with en suite shower room.

There is a fully enclosed garden with a fantastic degree of privacy.

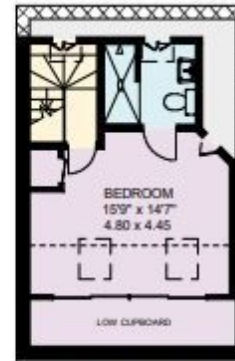




Ground Floor
