Located moments away from Hyde Park's green open spaces, this property is well arranged on the lower ground floor of a period terrace and benefits from a private entrance.

The sizeable property measures approximately 109.1 sq. m. (1174 sq. ft.) and comprises a long hallway on entry, providing access to all rooms. To the front of the property is one of the generous double rooms with built-in wardrobes and an en suite bathroom. There is a separate kitchen that features ample storage and integrated appliances. Next to the kitchen is a formal dining space that leads into the impressive reception room, which is flooded with natural light due to the vaulted ceiling and patio doors that lead to the rear private garden.

Oxford Street and the West End are both easily accessible offering some of the best shops, restaurants and theatres that London has to offer.

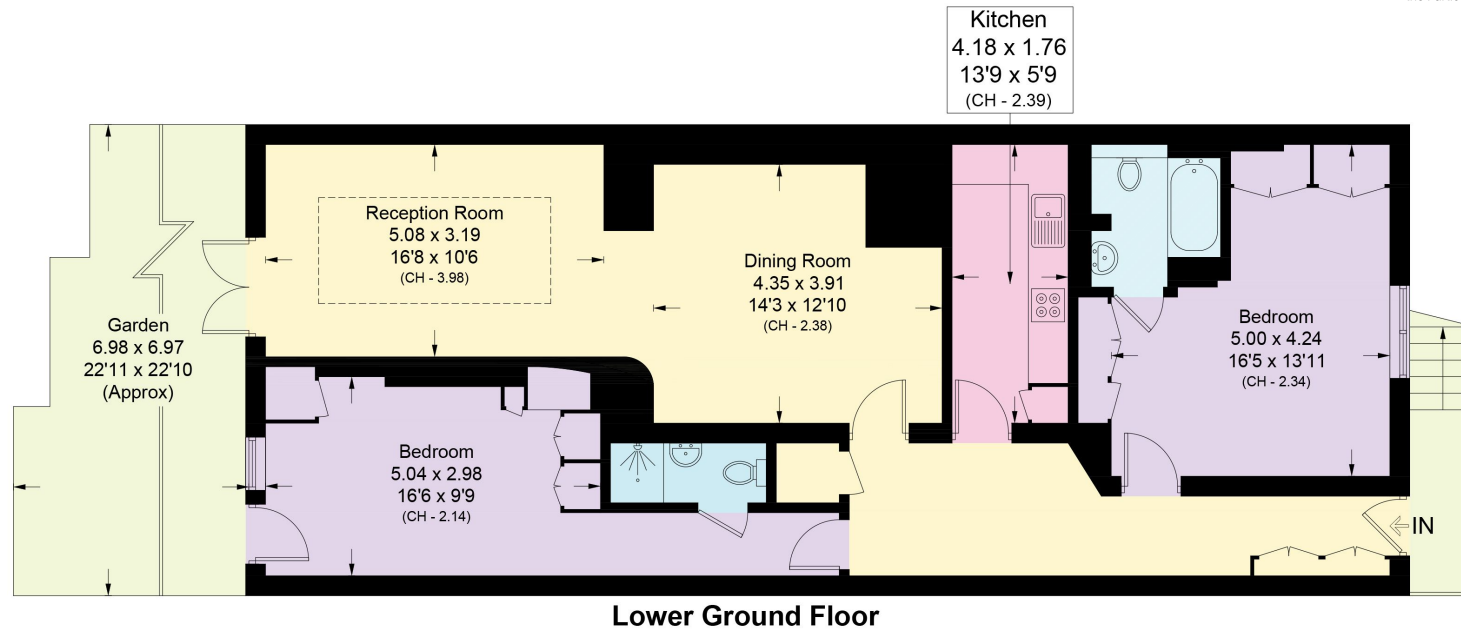
