MAJESTIC PERIOD FEATURES

Constructed circa 1699 The Rosary is a wonderful example of architecture from the William and Mary period, featuring a stunning five window wide facade with beautifully regimented fenestration and a striking oriel bay. The house is Grade II listed and was built back to back with The Hollies, as mirror images of each other, for the two grown up daughters of Nathaniel Rawlins - a wealthy Haberdasher merchant and property investor who lived at nearby Clarence House.

Due to it's prime position adjacent to Richmond Hill, you are within a short distance to some outstanding schools and the many famous attractions that make this area a very special place to live.


Local transport links include numerous bus routes to surrounding areas, plus fast and frequent trains to Central London via both South West Trains (Waterloo 19 minutes) and London Underground's District Line (West End 38 minutes).

Schools in the area include King's House School (0.6 mile), Old Vicarage School (0.2 mile), Marshgate Primary School (0.8 mile), The Vineyard School (0.5 mile) and The German School (1.1 miles)






Upper Ground Floor




Lower Ground Floor
