



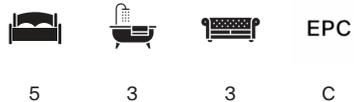

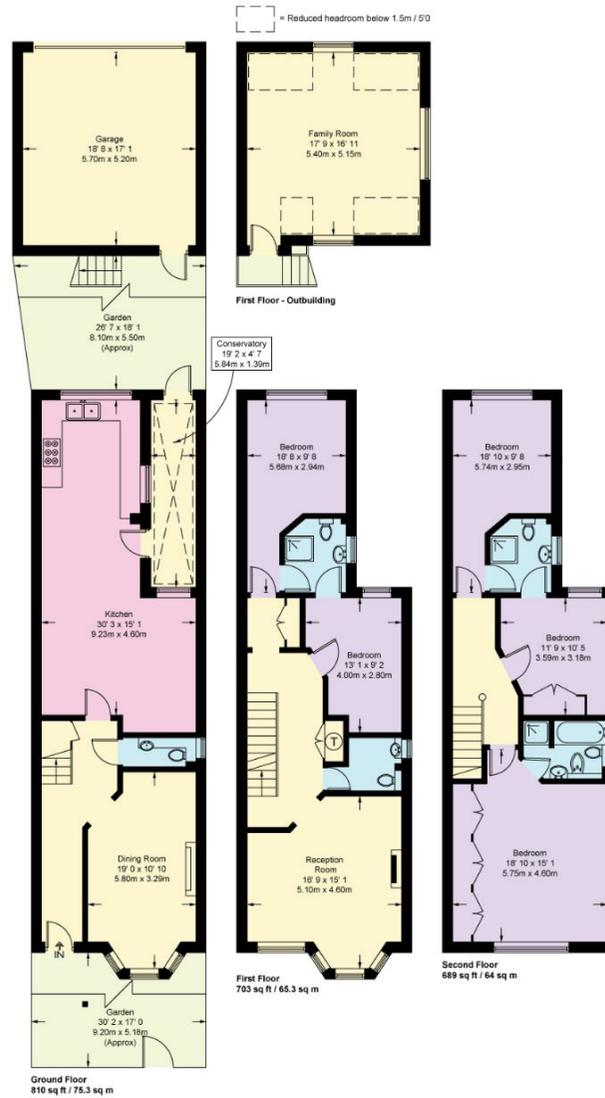
A beautifully appointed family home offering approximately 2,850 sq ft of refined and versatile living space.
