GROUND FLOOR


This charming Grade II Listed farmhouse has been cleverly extended and restored, with superbly presented accommodation throughout that has been well maintained by the vendors.

The front door opens to a full height entrance hall with impressive oak staircase to the first floor. Stairs behind this lead down to a cellar that could be used as study, gym or a variety of purposes. Both reception rooms are of a good size and enjoy dual aspects, a wealth of original timbers and wood burning stoves with an impressive inglenook fireplace in the sitting room. The generous farmhouse style kitchen/dining room has a comprehensive range of cabinetry, wooden worktops, range cooker and a large dresser. Adjacent, the utility room has direct access outside.













FIRST FLOOR & GROUNDS

On the first floor are three bedroom suites, all with well appointed bathrooms. The principal bedroom has a stunning vaulted ceiling and generous ensuite bathroom with separate shower. The guest bedroom is accessed via a staircase in the dining room and also enjoys a vaulted ceiling.

The house has a long gravel driveway with formal gardens to one side. These continue around the house with terraces and a kitchen garden. There is a substantial American barn with superb stabling consisting of 8 stables, tack room and grooms area. A barn has lapsed planning for ancillary accommodation alongside a further large open barn. Planning permission was also obtained in June 2021 for the construction of a horse riding arena (21/502235/FULL).

The land is divided into paddocks with water and there is picturesque area of woodland.
