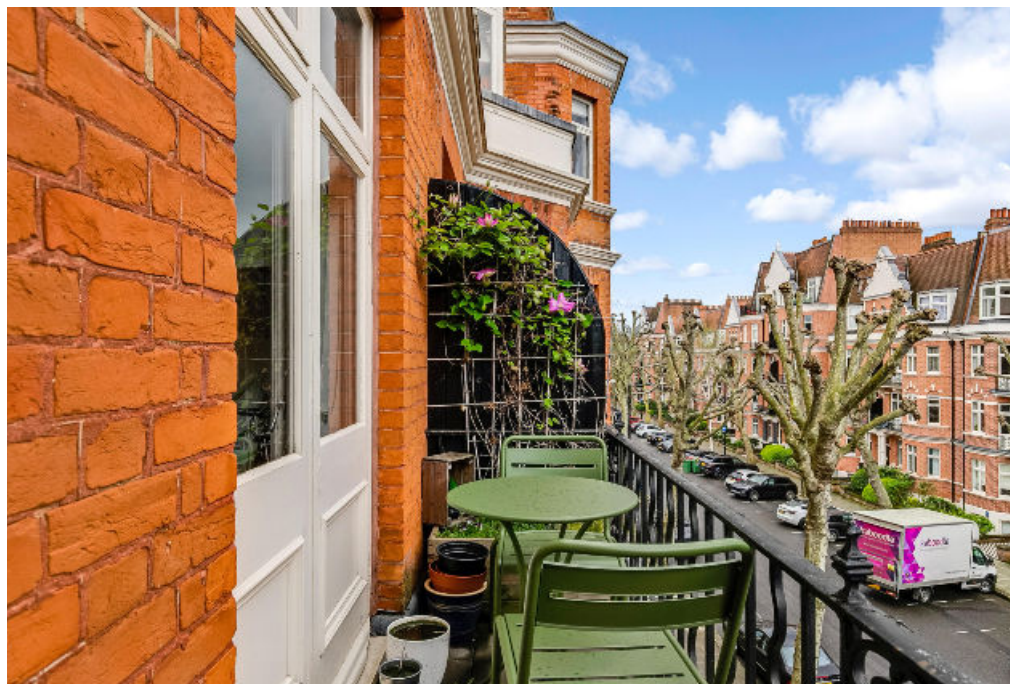




## Location
