The Villas of the Park Villages were Nash's final contribution to Regents Park and his idea of houses of various styles set in a winding 'country' road was adopted by many Victorians suburban builders.



Park Village West lies off, and is approached from the northern end of Albany Street, which runs parallel to the Outer Circle of Regents Park. It is well placed for local shopping facilities in Parkway and for public transports.
