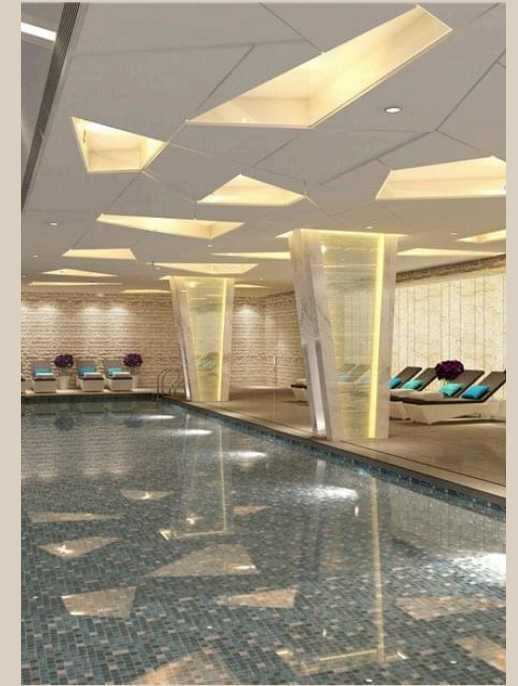

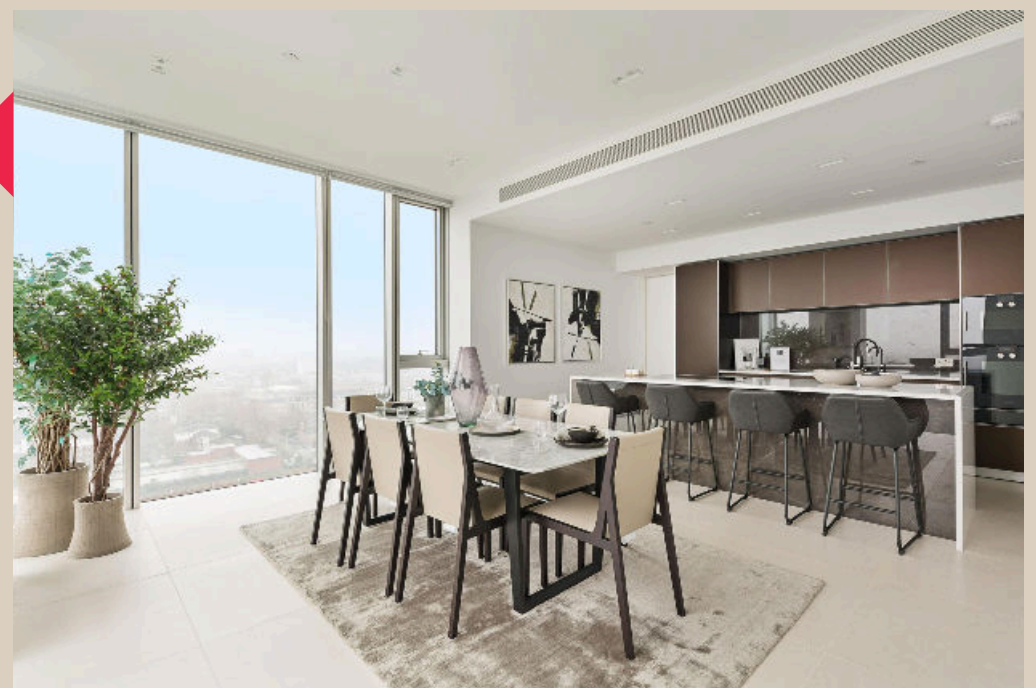


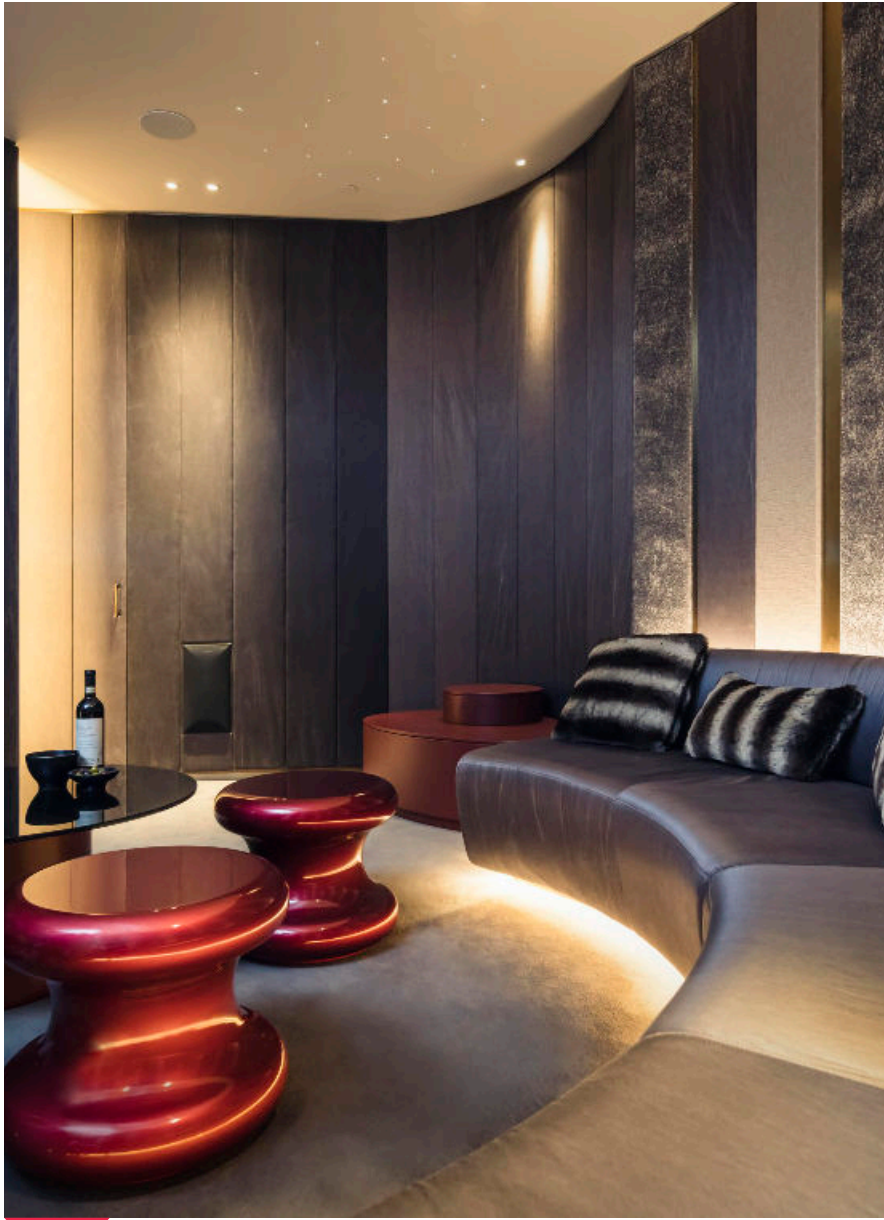
The Penthouse has direct access to the Residents only Club House at the base of One Lillie Square





Constructed of stone and glass, they epitomise the quality and character of Lillie Square, also echoing the Georgian and Victorian architecture of the surrounding area.

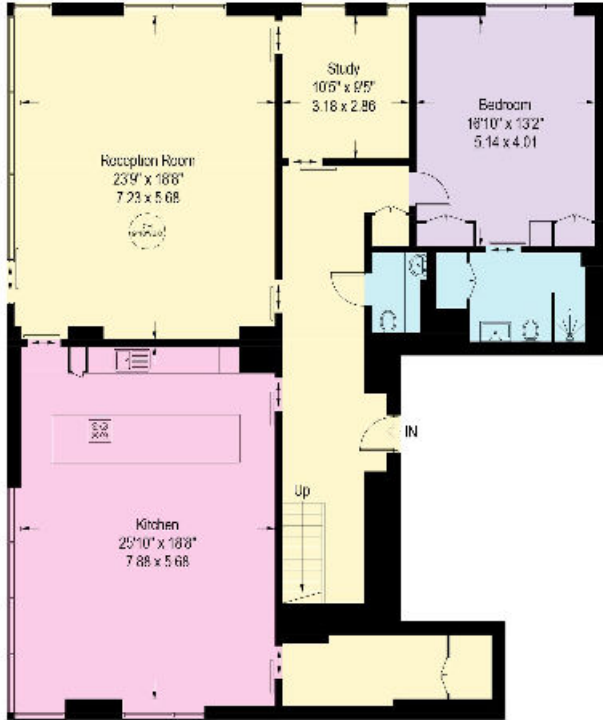

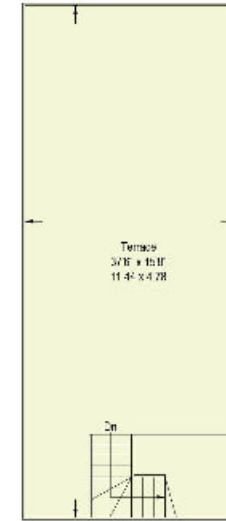
